## **Room Scheduling Process**

\* Schools receive priority room listings for rooms they are authorized to utilize. Deans distribute listings to chairs and indicate which rooms are available to each department. For rooms outside the department or outside the school, chairs confer with their dean. Only deans may request rooms from outside their priority room list. Chairs make room changes directly in the Scheduler until 8/14/15 and secretaries make room changes until 9/11/15.

\*\* After 9/14/15, priority room listings are no longer in effect. VPI Office personnel in coordination with deans and secretaries provide rooms for Clsrm CRNs. \*\*\* Tentative Dates – Dates are determined by District Instructional Services.
