W. Tappen distributed a handout regarding the change of name <u>Technologically Mediated Instruction</u> (<u>TMI</u>) to <u>Distance Education Course</u>.

A DRAFT of suggested guidelines that is being developed by CIC for course changes from associate to baccalaureate designation was also distributed by W. Tappen. Comments/further suggestions regarding this DRAFT should be directed to him.

W. Tappen noted that the two revisions for Procedure 5300.2 Section 7 are still in the DRAFT stage at CIC and that NUTR 191 had been renumbered to NUTR 391.

A limited number of the Mesa College ADDENDUM to 2000-2001 College Catalog was received by the college. It was noted that the addendum is not meant for student usage but for internal college use – Counselors, Matriculation, etc. W. Tappen distributed reproduced copies of the addendum to the committee members.

W. Tappen spoke of his appreciation for the hard work and attendance of the Curriculum Committee and the Tech Review Committee members. He encouraged them to continue this commitment and requested that they impress upon their colleagues the importance of completing the integration of course outlines. He noted that there are still over two-thirds of the District's courses that need to be integrated.
