She explained that the template presented was based upon SDSU and UCSD model. Although there were several questions concerning the model, Susan Newell agreed that this type of document would be useful. The chair requested that Ms. Newell prepare a written analysis for the next Curriculum meeting and in the meantime, the document will be forwarded to the Academic Affairs Committee for their review.
