The 290 & 296 draft course outlines are still under discussion at CIC. It was noted that the 290 outline needs the (FT) notation as field trips are included in the METHODS OF INSTRUCTION. Committee members may contact W. Tappen with any other comments/concerns.

R. Dewes inquired if the curriculum committee can be proactive in regards to IGETC (HIST 100 & 101). This item will be placed on the committee's November 2 agenda.
