- W. Tappen informed the committee that CurricUNET approval would not be available or defaulted during the Winter Break.
- E. Armstrong informed the committee of Mesa's discussions on repeatability of courses. A standard language to enter into the course description for repeatable courses will be presented to CIC.
- L. Corbin reported that she is concerned with the lack of courses Mesa faculty has launched. The originator's responsibility to both pre-launch and then launch a proposal was discussed. The possibility that the originator does not realize that pre-launch and launch are two separate processes may be why some proposals have not yet entered the CurricUNET approval process. In addition, it may be that some department chairs and discipline faculty are not yet following through with their CurricUNET messages, resulting in a number of course outlines being defaulted through the approval process. W. Tappen will look into these problems.
