- * **Mesa Academic Senate Constitution – Update**
 - M. Parsons will take the committees' recommendations to change the Curriculum Committee portion of the constitution to the Academic Senate meeting on Monday, February 24, 2016.
- * **National U/SDCCD MOA – Handout/Discussion/Vote**
 - J. Parker reviewed the MOA with the committee and pointed out several areas where it did not meet SDCCD acceptance and use of credit policy, or the mission of the Transfer MOU Committee.
 - It was also pointed out that the established process for creating an MOA was not followed.
