Information

- * It was noted that SDSU is not currently updating articulation agreements in ASSIST which is a challenge. Currently Continuing Education is looking into improving the process for students going from non-credit courses to credit courses. CIC had a virtual meeting on January 30, 2025.
- * The Program Viability statement has been adjusted so it does not specify the final decision being made by a "College Executive Committee." The plan is to reevaluate in a year.
- * META was not shut down for proposal approvals during semester breaks so be sure to check that proposals were not moved forward without being reviewed by Deans and faculty. Continuing Education proposals are now available for review in META.
- * The taser resolution was delayed for technical reasons. A syllabus template from Mesa's Academic Senate was presented and reviewed. A number of adjustments were recommended and it will be brought back for a vote at a later date.
- * J. Estep reported the inputting/adjusting of Outcomes has been closed.
- * Mesa's Catalog Committee's next <u>Zoom meeting</u> will be 3:00pm on February 11, 2025. The second review of the 2025-26 catalog is currently taking place. J. Estep demonstrated how members can access the catalog in Meta. Anyone interested in being a member should email J. Estep.
- * Mesa continues to wait for the state approval of the Physical Therapist Assistant Baccalaureate Degree.
- * There was no update for Ethnic Studies.
- * The next meeting of the District GE Task Force will be February 21, 2025. Please contact J. Estep if interested in being on the GE Task Force.
- * There was no update on Cal-GETC.
- * The LAS Degrees continue to be developed and it was recommended to have them completed by March 2025.
- * J. Bernal reported a flowchart has been developed for Math Placements and Milestones. The flow chart has been posted online.
- * The AB 1111 surveys for the Phase 2 templates ended Friday, February 7, 2025.
- * J. Estep has researched how other community colleges are implementing IDEAA (Inclusion, Diversity, Equity and Antiracism and Accessibility) into course outlines. It was suggested that a small number of IDEAA experts review proposals and provide suggestions for inputting/expanding IDEAA into the proposal. The consensus of the committee is to potentially have IDEAA reviewed and input into proposals as part of the Tech Review.
- * The virtual vote on December 10, 2024 to add credit for prior learning (CPL) to MEDA 084 passed. J. Estep thanked members for voting.
