- * The Curriculum Reporting for the Community Colleges (CRCC) Project will be presented at the November 16, 2006 CRC meeting.
- * P. Gustin informed the committee that CIC approved the change from Student Learning Outcomes to Student Learning Objectives in course outlines.
- * P. Gustin reported that CIC agreed to have two GE review dates one in November and one in May. After discussion the consensus of the committee was not to have GE information included in course descriptions.
- * J. Parker's summary handout distributed at the October 26 meeting on the Lower Division Transfer Patterns (LDTP) project is available from A. Svedberg.
- * P. Gustin reviewed the Course Integration handout and informed CRC members of the new Six Year Review report that is now available through CurricUNET. This report lists all three college's courses and projects through the year of 2012 each course's review due date. The report is downloadable into an Excel file for sorting and reviewing individual portions of it. The Mesa's Six Year Program Review is created from data in this report.
- * P. Gustin explained the purpose of the CIC Action List handout is to keep members informed of items being discussed at CIC as well as the date items are resolved.
- * The CurricUNET User Group Conference held Friday, October 27 at City College was well received and informative. P. Gustin reported that other colleges seemed to have more direct contact with Governet at the college level. Several possibilities of increasing CurricUNET usage by SDCCD included:

 - Articulation Module
 - Program Review
 - Catalog and Schedule Production
- * P. Gustin informed members of the number adjustment of DRAM 110 to DRAM 112 as the DRAM 110 numbering had already been utilized.

- * P. Gustin reported on the updating of CurricUNET for enhanced program inputting.
 - The majority of suggestions will be implemented by CurricUNET during the January break.
 - To assist in program revisions the colleges will be removing "umbrella" listings into their own individual program listing.
 - The Program Impact (PI) report had been adjusted at the SDCCD level by utilizing new courses rather than revisions. This will be reviewed further by the Steering Committee.
