- * After discussion of proposals defaulting and being held up by Discipline Deans' approvals in CurricUNET the consensus of the committee is to have the CRC chair take this concern to CIC for clarification as to the Discipline Dean role in CurricUNET and for an updated listing of Discipline Deans.
