- * By consent **GISG 111** a Mesa course revision proposal was moved to First Read.

First Read Curriculum

- * MSC S. Newell/R. Olson to submit **MEDA 112** a Mesa only course revision to Tech Review.
- * After discussion the consensus of the committee is to have Distance Learning requests cover the broad spectrum of Distance Learning with specific parameters for the individual course.
- * MSC L. Horsman/S. Newell to submit **CHEM 152** a Mesa only Distance Learning proposal to CIC.
- * By consent **NUTR 150** a Mesa only Distance Learning proposal was moved to Second Read and P. Gustin will contact originator to make changes.

Second Read Curriculum

- * MSC Y. Bergland/S. Newell to submit **PHIL 102A** a Mesa only Distance Learning proposal to CIC after originator changes and P. Gustin's review.
- * MEDA 113 & MEDA 115 remain at second read to allow originator to input Tech Review recommendations.
- * PHYE 191 remains at second read to allow originator to input Tech Review recommendations.
- * CISC 221 a Mesa only new course will remain at second read until notified by originator.

Information/Discussion

- * Y. Bergland informed the committee that all of Mesa's walk-in proposals were approved with City activating the new Mesa only GISG 104 course.
- * After discussion of the challenge of meeting CIC deadlines especially by small staffed vocational programs the consensus of the committee is to recommend Mesa acquire a Vocational Curriculum Specialist. P. Gustin and E. Armstrong will explore this recommendation and develop guidelines if such a position becomes a reality.
- * P. Gustin discussed the new Guidelines to Course Revisions (March 1, 2007) with the committee and requested members to review the guidelines and bring recommendations/ suggestions for changes to the March 29 CRC meeting.
- * P. Gustin informed the committee LCOM proposals will now go through the CurricUNET process as Generic proposals.
- * CurricUNET testing for improving program inputting will be done during the Spring Break with the adjustments ready for use in Fall 2007.
- * The Academic Senate's statement resolving the need for curriculum approval for courses offered for less than 5 weeks will be presented to the committee when available.
- * J. Parker stated articulation is being affected and it was understood this would not happen in the transition from CAN to Lower Division Transfer Pattern (LDTP). Region 8 Articulation Officers have written a statement to address the issues of the LDTP prior to continuing their submission of outlines. Region 10 is developing a statement in support of Region 8 and will also place a hold on their submission of outlines.
- * Mesa currently has three categories of outlines being reviewed for spring 2007 LDTP submission. CSU will have another submission cycle in the fall.

 - Outlines to be Submitted at a Later Date
- * The Tech Review report for March 8 was distributed.
- * CIC Partial Action Summary Handout of approved items for 2/22/07 was emailed to committee members.
