Agenda/Minutes

- * MSC M. Cox/J. Keller to approve the October 20, 2022 agenda with postponement of item 2.6. Credit for Prior Learning – H. Eskew until next meeting.
- * MSC M. Cox/N. Resch to approve the October 6, 2022 minutes as written and yellow highlighted items accepted into the record with six abstentions. J. Estep commented the MATH 150L that was supported by CRC is being restarted through the approval process as a Revision including Activation proposal.
- * J. Estep welcomed everyone and self-introductions were made.

Information

- * CIC Report.
 - J. Estep reported the CYDA Designator previously supported by CRC will be voted on at CIC next week.
 - There are numerous policies and procedures undergoing review with the goal to move them forward after the October 27, CIC meeting. There is some support for exploring a change to the BP 4070 Course Auditing procedure, and additional discussions are in progress.
 - Three of Mesa's Academic Senate resolutions were presented and approved by CIC: 2022.9.1 Faculty Primacy Over Curriculum; 2022.9.2 Establish an Equitable CSUGE-BE and 2022.9.3 Lifelong Learning.
 - C'Net Steering Committee is looking at whether additional Methods of Instruction should be included to the options on the dropdown list in C'Net Meta. C. Kinney reported that Guest Speakers is a frequent item manually input into this section. J. Estep indicated that if anyone has any other suggestions to e-mail him.
- * J. Estep reported C. Kinney, J. Parker and himself, presented the Chair Curriculum Training Friday, October 14, 2022 with approximately 10 chairs in attendance.
- * J. Estep indicated the Annual Certification of Mesa Curriculum, due in November, has been completed and sent in. He reminded CRC members that previously all courses and degrees were reviewed by the state, but now colleges are responsible for the review of those courses and degrees listed in the report.
- * J. Estep indicated that Mesa Academic Senate has approved all of the resolutions. The Auto Enrollment resolution was amended from a two-week period to the first week of classes.
- * J. Parker commented that the Ethnic Studies Minimum Qualifications and the three curriculum resolutions: 2022.9.1 Faculty Primacy Over Curriculum; 2022.9.2 Establish an

Equitable CSUGE-BE and 2022.9.3 Lifelong Learning passed through Area D this past weekend.

- * J. Estep reminded the group the Mask Mandate Resolution was initiated by the chemistry department in response to challenges they are having with the mask mandate in their laboratory courses. He asked for CRC input since he will be voting at Senate. There was discussion that some exceptions to the mandate are currently in place while maintaining instruction, but without compromising safety, and that perhaps chemistry could explore that avenue if this resolution does not pass.
- * J. Parker presented three GE patterns being vetted right now for the California Community Colleges. 1) CalGETC that combines CSU GE Breadth and IGETC, 2) CCC Associate Degree GE Pathway that will change from 18 to 21 semester units, and 3) proposed CCC Baccalaureate Degree GE Pathway (Lower Division) to align with other patterns while allowing some flexibility of the colleges as appropriate to their specific degrees. The lower division patterns will have to be submitted for Title 5 changes. Any questions or comments can be submitted to Juliette via e-mail.
- * The Credit for Prior Learning report by H. Eskew was tabled to the next CRC meeting.
- * J. Estep asked E. Rabinovich if there were any updates from the [Committee on Outcomes and Assessment/COA](#). E. Rabinovich indicated that the COA Handbook is currently being updated and will be presented to the Mesa Academic Senate soon.
- * J. Estep reported our CRC has three new members: J. Keller (Dramatic Arts), J. Johnson (Professional Learning Coordinator/LRC) and T. Ackerson (Associated Student Representative). The CRC Fall 2022 Membership Chart has been revised to include them. The chart was emailed to members and is posted on the [Mesa CRC website](#).
