**Agenda/Minutes**

- \* MSC M. Cox/C. Lopez to approve the November 3, 2022 agenda.
- \* MSC C. Kinney/T. Nguyen to approve the October 20, 2022 minutes with the adjustment of ASML 255 to AMSL 255. There were six abstentions.
- \* J. Estep welcomed everyone, and self-introductions were made.

**Information**

- \* J. Estep reported CIC approved the City College's new Cyber Defense and Analysis (CYDA) subject indicator. The CIC Administrative Policies and Board Policies are waiting on one college senate for final approval. The CurrIQnet Meta Steering Committee continues to meet on Friday twice a month.
- \* J. Estep reported the Mesa Academic Senate passed the Chemistry lab mask resolution and must now go to the other colleges Academic Senates for approval. In the spring the Senate will have face-to-face meetings, no more Zoom meetings. During the CVC roundtable there was discussion regarding the asynchronous instruction method. There was a Student Equity and Achievement (SEA) presentation. The Committee on Outcomes and Assessment (COA) presentation was cancelled.
- \* J. Estep requested a CRC member be a representative for the California Virtual Campus-Online Education Initiative (CVC-OEI) as he is unable to attend the Wednesday 9:00am ZOOM meetings. Please email J. Estep if you are interested.
- \* The NUTR 150 revision/DL was approved at the October 20, 2022 meeting but needs approval to walk it into CIC.
- \* MSC N. Resch/M. Cox to walk-in NUTR 150 to CIC.
- \* The Credit for Prior Learning presentation was tabled. I. O'Connor announced Tonya Whitfield is the Faculty Representative.
- \* J. Estep informed the committee of the possibility that the COVID State of Emergency would be ending in February 2023. If this happens, CRC meetings will revert to in person meetings in LRC 435. I. O'Connor commented the Board of Trustees would take into consideration the offerings of Spring 2023 to continue as scheduled rather than disrupt courses already scheduled. For Summer 2023 and Fall 2023 it is best to schedule courses according to the Distance Learning mode listed on the course as the emergency Distance Learning may not be acceptable.
- \* J. Parker informed the committee she is attempting to preempt the impact of AB 928 by requesting four revision proposals for GE submission in December 2022. The BLAS 165,

CHIC 210 & HIST 154 have been launched in CurricUNET. The NUTR 150 is ready to go to CIC and PSYC 112 is tentative. If you would like more information, please email J. Parker.
