- * MSC J. Bernal/A. Saballett to approve the November 17, 2022 agenda with the addition of item 5.13. CACM 103 – Revision – Mesa Only Walk-In.
- * MSC M. Cox/N. Resch to approve the November 3, 2022 minutes. There was one abstention.
- * J. Estep welcomed everyone, and self-introductions were made.

Information

- * J. Estep reported the last CIC meeting for the fall semester will be December 8, 2022.
- * J. Estep shared a draft copy of the Program Request Form Questions and Prioritization Process for the hiring of faculty the Mesa Academic Senate is voting on. J. Estep reported there are challenges with the draft and he has abstained from voting on it. Please email J. Estep if you have comments about the form and/or as to how you feel J. Estep should vote on behalf of the committee.
- * J. Estep reported J. Snyder has volunteered to be the representative for the California Virtual Campus-Online Education Initiative (CVC-OEI). J. Estep thanked J. Snyder for volunteering.
- * T. Parsons provided information on students obtaining Credit for Prior Learning (CPL). If a course allows for CPL it will be listed on the course in CurricUNET. When a student applies for CPL and the course has been CPL approved the application is entered into a shell and faculty/chair can access the student's portfolio and enter a grade if there is one. The biggest challenge is the workflow. The Military Articulation Platform (MAP) is being updated and it is a lengthy process. I. O'Connor asked if students will be given credit at UC's like a credit by exam course grade. J. Parker responded each UC department will decide individually as to whether or not to accept the CPL for major requirements. J. Parker and J. Estep thanked T. Parsons for her presentation.
- * J. Estep informed the committee the COVID State of Emergency will end on February 28, 2023. The question of continuing CRC Hyflex meetings for February 2 and February 16, 2023 will be discussed at the December 1, 2022 CRC meeting.
- * J. Estep reminded the committee that the December 1, 2022 CRC Meeting is the last meeting for the fall semester and that it is important for everyone to attend. If you cannot attend, please have a proxy. And as a reminder it is recommended that proxies be faculty/faculty; administrator/administrator to provide the best representation.
