Agenda/Minutes

- * MSC M. Cox/P. Ly to approve the February 2, 2023 agenda
- * MSC C. Kinney/J. Snyder to approve the December 1, 2022 minutes. There were 3 abstentions.
- * J. Estep welcomed everyone to the new CRC spring semester and self-introductions were made.

Information

- * J. Estep reported the COVID State of Emergency ends on February 28, 2023.
- * J. Estep informed the committee the virtual vote to have the February 2 and February 16, 2023 CRC meetings as Hyflex was approved. The approved calendar B of meetings was emailed to members.
- * J. Estep mentioned there have been numerous membership changes for the spring CRC committee. J. Estep inquired if the committee would like to add more members. The consensus was to add more members. J. Estep will look into this. An updated committee membership list of current members will be emailed to members.
- * J. Estep reported CIC approved a number of policies and procedures, discussed Career Technical Education Programs that do not have any CTE courses and baccalaureate degrees.
- * J. Estep presented the two Board of Governors' (BOG) files that were emailed to members on changes to student withdrawals and P/NP situations. While there are numerous changes A. Svedberg stated there were two items that stood out. (Highlights added for emphasis.)
 1. State aid and repeatability rules are the same for withdrawals under both types of emergency situations; and Withdrawals for extenuating circumstances are **all treated as excused withdrawals**.
 2. Courses in which wherein each student may elect **until the last day of instruction**, as established and published by the districts, on registration, or no later than the end of the first 30 percent of the term, whether the basis of evaluation is to be "pass-no pass" or a letter grade
- * I. O'Connor discussed the two files (SDSU/Region 10 Articulation Discussion) emailed to members. She informed the committee she worked with CIOs and Articulation Officers on a memo dated December 15, 2022 and sent it to SDSU regarding articulation obstacles with SDSU. On January 18, 2023 a small group met to discuss SDSU Region X Articulation and the meeting had positive results. More meetings and discussions are planned. J. Parker thanked I. O'Connor for her leadership in assisting students in transferring courses to SDSU.

- * I. O'Connor shared the AB1111 attached update and commented the information listed are recommendations and ideas for implementing AB1111. Comments/feedback is welcome and should be emailed to I. O'Connor.
- * J. Estep reported two resolutions (2022.12.1 FHP Approval Process and 2022.12.2 Removal of Officers) are being voted on by the Mesa Academic Senate and requested the committee let him know if they had any preferences as to how he should vote.
- * J. Parker reported BLAS 100 was approved for Area F.
- * J. Parker stated meetings with CSU regarding BLAS 140A and BLAS 140B approval for Area F have not developed and requested a vote to have BLAS 140A and BLAS 140B submitted for Area 7 approval.
- * MSC N. Resch/M. Cox to have BLAS 140A and BLAS 140B submitted for Area 7 approval as a walk-in to CIC.
- * J. Parker reported the resolution to keep Area E in the CalGETC was approved by the State Academic Senate. The President of Community Colleges and I. O'Connor support keeping Area E.
- * J. Estep indicated a vote is needed for Miramar's new subject indicator: Public Safety Management (PSMA)
- * MSC C. Kinney/N. Resch to approve Miramar's new subject indicator: Public Safety Management (PSMA).
- * J. Estep informed the committee Mesa Baccalaureate Degrees may become a standard item on the agenda as more Mesa departments are looking into applying for baccalaureate degrees.
