- * J. Estep reported the Program Viability team gave a report to CIC on the progress and process team is utilizing to review programs. A tracker program has been created to assist in updating ADT's TMCs and narratives with AB 928's Cal GETC information prior to the June 1, 2024, The AB 1111 Common Course numbering is preparing for a 2027 implementation.
- * The January 25, 2024 **Introduction to the New Curriculum Management System – CurriQunet Meta** memo from Vice Chancellor, S. Topham was reviewed and discussed. It is anticipated the system will be fully operational by February 14, 2024. Training and support will be made available to users. The memo/handout was emailed to the committee.
- * J. Estep informed the committee the Academic Senate's first meeting for the semester is February 12, 2024.
- * J. Estep reported there is no update on Baccalaureate Degrees.
