- J. Estep reported Miramar's new subject indicator: Public Safety Management (PSMA) was tabled. - J. Estep reported the Mesa Academic Senate passed the two resolutions (2022.12.1 FHP Approval Process and 2022.12.2 Removal of Officers).
- J. Parker shared the State Academic Senate's February 9, 2023 Intersegmental Committee of the Academic Senates (ICAS) report. The report lists the 11 courses (34 units) that comprise the California General Education Transfer Curriculum (Cal-GETC) and recommends colleges to consider including lifelong learning and self-development (LLSD) in local degree requirements
- * J. Estep informed the committee Mesa Baccalaureate Degrees will be a standard item on the agenda and currently there are no updates.
- The LOFT Leafs Presentation was presented by M. Rodriquez and A. Primoza. It was explained a goal of the Career Ambassadors Program (CAP) is to increase literacy of environmental issues and adding a Leaf icon(s) to courses listed on the online schedule will inform students of courses that cover climate crisis, environmental justice and/or environmental sustainability. Two leaf icons on a course would indicate that the course has a primary and explicit focus on sustainability. One leaf icon on the course would indicate the course incorporates sustainability challenges, issues, and concepts in a prominent way. There was discussion as to how courses will be designated as being eligible for Leaf icons. The Environmental Sustainability Committee's (ESC) approval is sufficient to add Leaf icons to courses listed in the online schedule. If faculty want to include sustainability

information on a Course Outline of Record (COR) they can do a course revision and the revision will be reviewed by the CRC committee but the Environmental Sustainability Committee's (ESC) approval is sufficient to add Leaf icons to courses listed in the online schedule.
