- * MSC C. Kinney/B. Malinis to approve the February 1, 2024 minutes. There were 2 abstentions.

Information

- * J. Estep reported the February 6/7, 2024 CRC virtual vote for the removal of the MATH 116 prerequisite on MATH 121 was approved. J. Estep will move this approval forward to CIC.
- * J. Estep explained the need for the unique FERM 140 DE only proposal for spring 2024.
- * MSC B. Malinis/J. Bernal to approve FERM 140 DE only proposal for spring 2024.
- * At CIC it was noted that Mesa lost approximately 200 in headcounts due to fraudulent student enrollment. Other actions by CIC were discussed under specific headings.
- * The new Curriculum Management System – CurrIQnet Meta is still not fully operational and S. Topham will be sending out information on the training and support will be made available to users.
- * The repetition of Work Experience courses is being discussed at CIC and more discussion is coming.
- * J. Estep brought forward the college catalog's accreditation statement for discussion.
- * J. Estep informed the committee the Academic Senate has a resolution to increase dues to \$5.00 a month. The Senate will have elections this spring and J. Estep encouraged CRC faculty to run for office. It was noted the election for a chair for CRC will also held this spring.
- * J. Estep reported there is no update on Baccalaureate Degrees.
