**Agenda/Minutes**

- \* MSC M. Cox/L. Hensley to approve the March 4, 2021 agenda with the addition of two Information items 2.6 Miramar Activation of CHIC Courses – C. Lopez and 2.7 Pass/No Pass(P/NP) – I. O'Connor and adjustment of POLI to LBAS in item 6.2.
- \* MSC M. Cox/E. Helscher to approve the February 18, 2021 minutes.

**Information**

- \* A. Hoffman informed the committee that after much discussion the Mesa Academic Senate approved the revised AP 5104 Contract Education. One discussion question was whether or not an instructor's FTEF would be affected. I. O'Connor answered that it would be.
- \* A. Hoffman reported Miramar's request for the new course designator Audio Production and Engineer/AUDI had the approval of all three college's Music departments. N.S. Robinson added this designator would be helpful to the Music departments as music courses utilizing it would be eligible for Perkin grant funds.
- \* MSC M. Cox/E. Helscher to support the new Audio Production and Engineer/AUDI designator.
- \* A. Hoffman reported Mesa's Academic Senate voted against applying to be a part of the State Chancellor's Competency Based Education (CBE) pilot program. I. O'Connor commented some Mesa faculty are interested in exploring CBE for their courses.
- \* J. Parker informed the committee the ASCCC C-ID Ethnic Studies discipline input group (DIG) meeting on Friday, March 12, 2021 did not go as planned. The goal of C-ID was to have Ethnic Studies faculty write course descriptors for the Social Justice Transfer Model Curriculum (TMC). Ethnic Studies discipline faculty are in favor of removing Ethnic Studies from under the umbrella of the Social Justice TMC to create separate autonomous Ethnic Studies TMCs; however, the State Academic Senate is not at this point. Another discipline meeting is scheduled March 25, 2021 to continue the discussion.
- \* I. O'Connor stated she would like to see as many of the committee members as possible attend the [2021 Curriculum Institute](#). She reminded members to contact her so she could register them. The Institute will be held virtually July 7-9, 2021.
- \* C. Lopez added Miramar's activation of CHIC courses to the agenda to discuss with the committee an English faculty member's qualification to activate CHIC courses and who has not been active in the Ethnic Studies Taskforce. I. O'Connor stressed the difference between activating courses and faculty assignments to teach the courses. She also encouraged Mesa to support Miramar as they develop a robust Ethnic Studies program.

- \* I. O'Connor updated the committee with the District's changes to Pass/No Pass (P/NP) grade regulations for Spring 2021 as listed in the March 2021 This Month in Campus Solutions. A. Dines requested clarification as to whether students can change their decision until the later deadlines. I. O'Connor looked into this concern and the answer is no.
- \* I. O'Connor informed the committee there will not be a printing of the Summer 2021 Schedule. Instead, a PDF copy of the Summer 2021 Schedule will be utilized and placed on the District's website for audit and historical purposes.

- \* The Music AA-T Degree remains at the State Inventory (COCI) level waiting for approval.
- \* The Chemistry AS-T continues to await more information from state officials before it can be resubmitted.
