- * J. Estep reported the District has hired more evaluators. We now have 9. The 2023 Curriculum Institute will be held July 12-15, 2023 in Riverside and also via HyFlex. The Friday, March 9, 2023 CurriQunet Meta Steering Meeting was cancelled. Policies and Procedures is working on the Credit for Prior Learning process.

CPL (Credit for Prior Learning) Process

This is a DRAFT of the Process for CPL. This version is updated even from the version I shared on Thursday (it includes the Faculty initiated part). Please provide any feedback you have (preferably by Wednesday since Policies and Procedures is on Thursday).

CPL Process DRAFT

- * J. Estep noted the Mesa Academic Senate is having elections. The Resolution 2023.3.1 Nuventive Software was discussed and the consensus of committee members was to abstain voting on it. After discussion, committee members recommended the approval of the ISER(Accreditation document).
- * J. Estep reiterated Mesa Baccalaureate Degrees will be a standard item on the agenda and currently there are no updates.
- * P. Ly presented a slideshow on the Native American Student Support and Success Program (NASSSP) grant application. CCCCO may provide up to 20 community colleges with one-time grants and Mesa was invited to apply. The funding will be allocated in two phases – Phase I in July 2023 and Phase II in July 2025. Strengthening Pathways, developing Mentoring/Leadership, ensuring Academic Success and establishing a local Native American student support and success program are the four NASSSP goals. Mesa's local program services will support the four NASSSP goals by peer mentoring, developing course-specific cohorts, building counseling and wraparound student services, and development and integration of faculty and staff professional development training. Grant recipients will use a portion of the grant to establish a full-time program coordinator and tribal liaison position to implement services and act as liaison between the community college and local Native American tribes for the creation and implementation of the program. Letters of interest are due April 7, 2023. At the end of April 2023, the finalists of 20 campuses will receive notification and if the college is awarded the grant a plan to implement it will be done during May-July 2023. Please contact P. Ly for more information.
- * J. Estep displayed the CCCCO's AB 1111 Survey and stated there is only one link for it. It was requested members contact J. Estep for further information and possibly the link.
- * An Area E update informed the committee more than 15,000 students had signed letters in support of keeping Area E – Life Long Learning – as a lower division graduation requirement.
