Agenda/Minutes

- * MSC M. Cox/L. Hensley to approve the March 7, 2024 agenda with item 2.10 Mesa Mapper – H. Eskew/M. Alioto moved to item 2.1.
- * MSC M. Cox/K. Secor to approve the February 15, 2024 minutes. There were 5 abstentions.

Information

- * H. Eskew and M. Alioto presented a slide show on the Mesa Mapper [Pathways Program Mapper (PPM)]. The mapping template software will provide students a semester-by-semester roadmap of courses needed for completion of their chosen award/program. The slide show is available upon email request to J. Estep/A. Svedberg.
- * I. O'Connor reported A. Dines has taken on the role of Mesa's Articulation Officer now until May1, 2024 when J. Parker will be returning.
- * There was no CIC report because the February 22, 2024 meeting was cancelled.
- * The new Curriculum Management System – [CurIQunet Meta](#) is partially operational. J. Estep demonstrated several screens and C. Kinney has begun to input proposals into the new system. District is providing some training and support for users via [ZOOM](#) on Fridays at 10:30am.
- * CIC is discussing the repetition of Work Experience courses. With the new Work Experience memos, it is felt the repetition issue may have been resolved.
- * J. Estep brought forward the college catalog's accreditation comment to CIC regarding U.S. Institutional Accreditation.
- * J. Estep informed the committee the Academic Senate has three resolutions they are discussing: Resolution 2024.3.1 (reaffirm protection of free speech), Resolution 2024.3.2 (climate) and Resolution 2024.2.1 (increase Senate dues) and one Administrative Procedure (AP 4250: Student Academic Standing).
- * J. Estep reported there is no update on Baccalaureate Degrees.
- * J. Estep announced the Catalog Committee did not meet during February but there will be a ZOOM meeting in March. J. Estep will send out an email as to the date and time. Everyone is welcome to attend. Please email J. Estep for information and the ZOOM link.
- * It was noted Mesa's 2024-25 college catalog lists Ethnic Studies and includes FILI 100.
- * A. Dines reported the new [District GE pattern](#) approved by CIC for 24/25 is being explored to update the local District requirements for 25/26. A workgroup will be convened to include disciplines from the outgoing CSU Area E category.

- * The Cal-GETC implementation is for fall 2025 but matriculated students will have catalog rights should they choose to continue with the old CSUGE/IGETC patterns. Work on changes to ADT templates has begun and the templates are forthcoming.
- * For the common course renumbering item, J. Estep reviewed the handout which charts the important milestones for AB 1111 and AB 928 at a two-year glance.
- * I' O'Connor informed the committee the Curriculum Institute 2024 will be held on July 10-13, 2024 in Pasadena. More information to come.
