Agenda/Minutes

- * MSC M. Cox/ B. Malinis to approve the March 21, 2024 agenda with the removal of CACM 132A and CACM 132D from item 4.1, removal of item 6.1. DENA: Dental Assisting (RDA, CDA) CA - Revision – Mesa Only (Walk-in to CIC) and an addition of (Walk-in to CIC) to item 4.4.
- * MSC B. Malinis/M. Cox to approve the March 7, 2024 minutes. There were 5 abstentions.

Information

- * A. Hedekin presented a slide show on the Liberal Arts/Science (LAS) Degrees. The discussion is to adjust the current numerous LAS degrees into five areas of more general emphasizes to provide students better access in obtaining an LAS degree. - * J. Estep reported the Viability committee will present a report to CIC report and because of spring break the next CIC meeting will be April 11, 2024.
- * The new Curriculum Management System – [CurriQunet Meta](#) is still in transition. J. Estep demonstrated how to sign-in to Meta. The District's Meta training via [ZOOM](#) on Fridays at 10:30am is unstructured and provides assistance to attendees that have specific challenges.
- * The [Dec. Work Experience Memo](#) listed under Legislative Information clarifies the Work Experience regulations regarding repeatability. Students can repeat work experience courses as dictated by local district policy. SDCCD gives credit to students for 16 semester units.
- * J. Estep reported changes to Title 5 will require (for the 2025 Catalog) the District to accept GE from any institutionally accredited institution (regionally or nationally accredited). As UCs only accept regional accreditation, District is considering options to provide students and transfer institutions with clear information about how GE requirements are met.
- * J. Estep informed the committee the Academic Senate approved Resolution 2024.2.1 which increased Senate dues. VPI Veronica would like faculty to email ideas for Mesa's 60th anniversary celebration.
- * I. O'Connor reported nominations for the CRC faculty co-chair are needed for the next two-year term (July 1, 2024 to June 30, 2026), C. Kinney nominated J. Estep who accepted the nomination and by acclamation was elected.
- * J. Estep announced the Catalog Committee will be having a ZOOM meeting in March. J. Estep will send out an email as to the date and time. Everyone is welcome to attend. Please email J. Estep for information and the ZOOM link.
- * The development of Mesa's Physical Therapist Assistant Baccalaureate degree continues to move forward.

- * There was no update on Ethnic Studies.
- * The Accreditation Team found numerous outlines that did not have Outcomes attached to them. These outlines were mainly new courses. One of the challenges of inputting Outcomes into outlines is that outcomes cannot be inputted into outlines until the outline has been approved. Another challenge is there are two systems -Meta and Nuventive - that are utilized for Outcomes and the two systems cannot be linked to share data. It was noted that the lack of Outcomes could possibly affect the Common Course Numbering so they need to be on all outlines. A possible solution is to attach the Outcomes to the course proposal as a document. The challenge of Outcomes will be taken to CIC.
- * A. Dines reported a workgroup is meeting April 5, 2024, to include disciplines from the outgoing CSU Area E category to the new [District GE pattern](#).
- * The Cal-GETC implementation is for fall 2025 and the [ADT templates](#) are now available on the chancellor's website. J. Estep and A. Dines will be attending the next Chairs meeting (April 10, 2024) to discuss implementation.
- * J. Bernal updated the committee that a new course (MATH 148) is being created for fall 2024 in Meta to replace MATH 141 to meet the STEM Calculus and AB1705 requirements. More information will be given at the April 4, 2024 meeting.
- * I. O'Connor informed the committee registration is now open for the July 10-13, 2024 Curriculum Institute being held in Pasadena. Please email I. O'Connor (with CC mzagyans@sdccd.edu) if you would like to attend.
