It was also mentioned that other courses fit district GE requirements but not transfer requirements. The originator mentioned that students have asked specifically for a class that focuses on Pacific Islanders, as well as overlap with the 4 areas that are approved and decided to keep District Ethnic Studies on the proposal.
