### C-ID Accomplishment Summary for 2010-11

#### **C-ID Year End Summary**

- Over 650 faculty from the CCCs and CSUs attended the Discipline Input Group (DIG) meetings in the north and south
- At present, 248 course descriptors in 16 disciplines have been approved (compared with 145 in 2 disciplines a year ago), including:

Recently added filters will make it easier for AOs to sort course information by discipline, college and date.

- 67 CCCs have courses that have been granted C-ID identifiers
- 500 courses have been granted C-ID identifiers for 11 disciplines
- If a course was automatically approved for C-ID due to it being approved by the CSU LDTP Project and granted a TCSU number, that course will be given a five-year review date from the date that the TCSU number was granted. We are working with our technology department to develop reports which will list your approved courses and their respective review dates.
