#### C-ID Advisory Committee

The C-ID Advisory Committee is comprised of faculty, articulation officers, and system office representatives from the CCC, CSU, and UC. Although currently vacant, a representative from the AICCU is also a designated member. The Advisory Committee, with counsel from the AO Subgroup, determines policies for C-ID. This group works in collaboration with the Intersegmental Curriculum Workgroup (ICW) on efforts related to SB 1440 and TMCs. #### C-ID Advisory Committee—update from last meeting:

- The C-ID Advisory Committee met in late February and discussed the following topics:
  1. Course content in excess of the descriptor requirement: The committee confirmed that it is acceptable for a COR to have more than what the descriptor calls for, but the COR must ensure appropriate coverage of the descriptor's content and objectives. Language will be added to policy documents indicating the need to ensure that the content and objectives of the descriptor are adequately addressed.
  - 2. *Appeals process*: The Advisory Committee reviewed the appeals process and proposed slight modifications to the language. It is anticipated that this document will be finalized at the April C-ID Advisory Committee meeting.

## ICW Group—update from last meeting:

ICW has approved exploring Ethnic Studies and Global Studies/International Relations as potential "area of emphasis" TMCs. *More information to come in the near future.* 

A non-substantive change to the Chemistry TMC was approved—the addition of the MATH 900s descriptor as an option. The updated Chemistry TMC is posted on the C-ID website.
