C-ID Verification Timeline for AA-T and AS-T Degrees:

Earlier communication from the Chancellor's Office established a deadline of June 1, 2014 for colleges to have "approved" C-ID status for all ADT courses for which C-ID descriptors are available. **The timeline is extended to June 30, 2015**.
