Message from Chancellor Mark Drummond regarding Board of Governors Motion on Assessment

Dear Community College Partners and Friends:

Improving student success is at the core of the System Strategic Plan that was adopted by the Board of Governors on January 17, 2006. Improvement in the achievement of students unprepared for college level work is the largest and perhaps most challenging aspect of this effort. The Strategic Plan places an emphasis on promoting college readiness and providing programs and services that enable all students to achieve their educational and career goals. Our ability to develop methods to more effectively assess student preparedness levels is fundamental to achieving this goal. Recognizing the importance of this issue, the Board of Governors (BOG) held a special session on March 4th devoted to assessment and student success. The session began with a presentation I made on factors leading to an economic and social collision that will result from divergent skill distributions, the changing economy and demographic trends as described in the ETS report "America's Perfect Storm". Pat Callan, President of The National Center for Public Policy and Higher Education addressed some of the same issues that he has highlighted in his "Measuring Up" higher education report card. Following a staff presentation on the system's current approach to assessment as a component of matriculation services, Karen Halliday, President of Las Positas College described their efforts to require orientation and assessment for more students. Findings related to assessment and placement from the recently released Review of Literature and Effective Practices for Basic

Skills as a Foundation for Student Success, recommendations from the Consultation Council's Matriculation Assessment Task Force chaired by Mark Wade Lieu, Vice President of the Academic Senate and a legal analysis of the Board's authority to alter assessment policy were also reviewed, followed by public comment. Based on the discussion, there was consensus among members of the BOG that some changes to existing policies may be necessary and that additional steps must be taken to further explore this complex issue before making any final policy recommendations. At their subsequent meeting on March 6th, the BOG heard public comment on the assessment topic and engaged in more discussion. At the conclusion of this discussion, the BOG unanimously adopted the following motion: "The Chancellor is directed to begin the process of evaluating the implementation of a system-wide uniform, common assessment with multiple measures of all community college students in consultation with the Community College League of California, Academic Senate and other community college partners for consideration and adoption by the Board of Governors by no later than November 2007. This evaluation shall be in concert with the System Strategic Plan and implementation process. In addition, and integral to the above, the Chancellor shall study policy strategies for consideration by the Board of Governors in the following areas: non-barrier access; student success; early assessment; orientation; prerequisites; failure to participate; funding; and exemptions." In adopting this motion, the BOG recognizes the complexity and sensitivity of issues surrounding this topic and the importance of involving all stakeholders in the evaluation. They also recognize that it is critical to move forward in a timely manner and have therefore specified a time frame within which to hold these discussions and bring back a recommendation for their consideration. Because of this time frame, I am requesting that all interested parties establish this as a high priority for consideration and that we work collaboratively as a system, as we have in the past, in order to bring back meaningful recommendations to the BOG that support improved student success without compromising the community colleges' mission of open access.



Message from the Chancellor cont...

Over the next couple of weeks, the System Office will begin talking with the practitioners, partners and constituent groups that we will need to assist us in responding to the BOG's motion. We will be asking our current consultation mechanisms, including the Matriculation Advisory Committee, System Advisory Committee on Curriculum, Chief Student Services Officers and Chief Instructional Officers associations, Academic Senate, Student Senate and Consultation Council to engage in discussion and planning for how we will respond to the BOG. We will also utilize the System Strategic Plan implementation groups to assist in this effort which is central to addressing the Basic Skills priority initiatives that we have all agreed are the key to improving student success. The entire system is being called on to review our approach to serving the real education and support needs of our students and providing what they need to be successful. This work will be carried forward by Carole Bogue-Feinour, Vice Chancellor for Academic Affairs and Linda Michalowski, Vice Chancellor for Student Services and coordinated by Executive Vice Chancellor Steve Bruckman. All of us are aware of the significance of the BOG's call for a more coordinated and aggressive approach to assessment and all of us are committed to implementing it in a way that will ensure continued access to the colleges for all populations while students are given the assistance they need to succeed. Please join us in this effort.
