### STREAMLINING UC ARTICULATION OVERVIEW

Issue: In 2004, the University of California faculty addressed the issue of "gaps" in articulation of major preparation courses between California Community Colleges and UC campuses (Streamlining UC Articulation). Articulation gaps made it difficult for prospective transfers to identify which CCC courses would meet major preparation requirements at specific UC campuses, since information on comparability of certain courses was unavailable. In 2005, the University faculty adopted SR 477, requiring every UC campus to articulate specific CCC courses/sequences when four or more UC campuses had already articulated them for common requirements in similar majors. The policy assured that no gaps in articulation would exist, even if a campus had not reviewed the community college class, provided the class had already been reviewed and approved by other UC campuses for the same major.

#### Policy Adopted—Additional Challenges

UC campuses recently have concentrated on completing articulation of all major preparation courses with all California Community Colleges; as of March 2006 that process is completed, which represents a doubling of articulation since 2001. Faculty remain concerned about major preparation, however, since even with all course articulation in place, students still face the challenge of deciding on a major from among over 900 different baccalaureate majors across the 9 general UC campuses and understanding the similarities and differences in preparation for each.

#### Implementation—Identifying Major Preparation Paths for Each UC Major

Even though each University campus major may have its own unique academic focus, a key aspect of the SR 477 policy is that every year the University must identify all commonalities in similar majors across campuses. The University faculty are working to leverage this information by providing students and advisors with related UC Transfer Preparation Paths for top University majors. These UC Transfer Preparation Paths: 1) Provide students with general descriptions of each major, 2) Identify all lower division degree requirements that are common across any UC campuses, 3) Identify all additional academic requirements at each UC campus, 4) Identify other – possibly unrelated – majors where the common preparation applies, and 5) Describe any additional criteria (gpa, minimum grades, etc) that students must achieve to be selected for admission at each campus.

The Transfer Preparation Paths establish a new framework to identify specific courses at every CCC that students can use to meet any of the lower division requirements. This information will be made available in addition to all of the current, traditional major preparation articulation the UC campuses maintain that cover all of the possible transfer options.

#### Current Status - October 2006

At the direction of the UC Academic Senate (BOARS and UCEP), initial Transfer Preparation Paths for four initial majors have been developed, reviewed, and posted for public access at <a href="www.UCTransfer.org">www.UCTransfer.org</a>. These include the statewide and campus-specific Paths for Biology, Chemistry, History, and Psychology majors.

The ASSIST Coordination Site is also using information on the common requirements in these four majors to conduct the SR 477 articulation analysis to identify any gaps in current CCC-to-UC articulation that might be filled.

This first phase was intended as a "proof of concept" to generate real, useful information and to inform a broader implementation. A full implementation plan is currently being developed that 1) expands the Paths to all top UC campus majors incorporating appropriate faculty consultation processes, 2) creates a computerized database so the information can be more easily maintained, updated, and displayed each year, 3) connects the Paths to CCC courses so students and advisors can see which specific courses apply, 4) conduct the SR 477 articulation analysis against all CCC-to-UC articulation for common requirements in all top majors, and 5) create better ways of using all of this information on a web site to help students and their advisors.

#### Combining Streamlining and Transfer Preparation Paths = Student Success

The new UC Transfer Preparation Paths combined with the extensive and comprehensive traditional major preparation articulation will be a powerful resource so that students can make the most effective use of California's robust community college system, attain baccalaureate degrees without accumulating unnecessary course units, and have the flexibility to move seamlessly through the transfer process if/when they change their interest in majors or University campuses.
