

Summary of General Education and Competency Requirements for San Diego Community College District (SDCCD) Associate Degrees

Effective 2008-2009

The SDCCD standardized the general education and competency requirements at each college for all associate degrees, including our new Liberal Arts and Sciences degree (replacement for Transfer Studies). The following information provides the details and differs from the May 27, 2008 message titled "08-09 AA Summary of GE and Competencies".



- Option 1 San Diego Community College District General Education pattern and District Requirements which include: American Institutions/California Government, Health Education, Physical Education, and Multicultural Studies
- Option 2 California State University General Education Breadth (CSUGE) pattern
- Option 3 Intersegmental General Education Transfer Curriculum (IGETC) pattern
- Option 4 San Diego Community College District General Education pattern. This option is only available to students completing the Liberal Arts and Sciences degrees designed for transfer. Students selecting this option should meet with a counselor.

Competencies (required for all associate degrees): Reading, written expression, and mathematics

New California State University (CSU) General Education and Transfer Executive Orders

The CSU has completed its revision of GE Breadth and AP policies, which has also cleared the way for final adoption of the revised IGETC Standards. The following letter from the Executive Vice Chancellor and Chief Academic Officer is the official announcement.

The CSU has completed work on three initiatives relating to general education and transfer.



Executive Order 1033: CSU General Education Breadth Requirements. This executive order supersedes EO 595. It maintains the familiar pattern of unit minimums and areas of inquiry, used by CSU campuses and community colleges throughout California as they coordinate general education in the lower division. To this it adds explicit recognition of the importance of GE program review, and a focus on learning outcomes as articulated in "Liberal Education and America's Promise," an initiative of the Association of American Colleges & Universities.

Thanks go to faculty leadership in the statewide senate, particularly the past two chairs of the Chancellor's General Education Advisory Committee, John Tarjan and James Wheeler, for their thoughtful and thorough review of our most fundamental statement of general education principles. The Chancellor signed this into policy on June 18, 2008.

Executive Order 1036: Systemwide Admission Eligibility and/or Baccalaureate Credit Awarded for External Examinations, Experiential Learning, and Instruction in Non-Collegiate Settings. This executive order supersedes EOs 365 and 366, and sets systemwide policy for recognizing prior learning in three distinct settings: as measured by external examinations such as Advanced Placement tests; as acquired through experience such as employment; and as delivered by instruction outside of traditional classrooms, such as in military training. Settings such as these are a

significant source of our students' education, and our continuing ability to recognize and document that learning is a vital part of keeping our admissions policies current, our students on track, and our degree programs timely and efficient.

The Chancellor signed this into policy on July 14, 2008. The new executive order charges the General Education Advisory Committee with maintaining and publicizing the list of acceptable AP scores, credit determinations, and GE Area placements for transfer students throughout the CSU. That list is available in Coded Memo AA-2008-28.

IGETC Standards. Faculty and staff from California's three segments of public postsecondary education have reviewed and consolidated the informal notes on implementation that have guided IGETC since its adoption in the early 1990s. For the first time, counselors, advisors, and articulation officers have a single reference to consult as they prepare students to transfer into either of California's public systems of four-year institutions.

The IGETC Standards were officially adopted late last year by the University of California and the California Community Colleges, and this spring by the California State University.

I congratulate the CSU faculty for taking such care to assure that these three policies work together to facilitate transfer, recognize prior learning where appropriate, and preserve the integrity and quality of our academic programs.

I am pleased to forward to you a joint memo from our colleagues at the University of California and the California State University announcing the adoption of a new *Intersegmental General Education Transfer Curriculum (IGETC) Standards, Policies and Procedures* handbook. The work that went into development of the handbook reflects extensive efforts by representatives of the three public segments of higher education to provide greater clarity to our colleges and students on IGETC Certification. It has been reviewed and endorsed by the faculty senates in each of the three segments and by the Intersegmental Council of Academic Senates (ICAS).

The IGETC Standards, which were originally released in 1991, have now been expanded into a well-organized, 31-page searchable webbased manual, which can be found under the IGETC tab at the California Community Colleges Transfer Counselor Website (www.cacctcw.com). Additional clarifying information is included at that site and will also be sent in a follow-up communication to Admissions Officers and Registrars, Articulation Officers and Transfer Center Directors.

I would like to take this opportunity to thank everyone who contributed to this very important effort to help facilitate the transfer of students from the California Community Colleges to California's universities.

We are pleased to announce that the University of California and the California State University have adopted as official transfer policy the new "Intersegmental General Education Transfer Curriculum (IGETC) Standards, Policies, and Procedures" document. Policies and procedures set forth in the Standards may be deemed effective immediately, for both the UC and CSU systems.

The new policy handbook was drafted by an intersegmental committee and endorsed by the University of California Board of Admissions and Relations with Schools (BOARS); the Academic Senate, California State University; the Academic Senate for California Community Colleges; and the Intersegmental Council of Academic Senates (ICAS). As this breadth of support indicates, the IGETC Standards are the result of substantial collaboration by our state's segments of public higher education. In a single document, these revised standards update longstanding customs and informal bulletins dating back to the early 1990s, and provide California's transfer students and their advisors with a convenient, transparent and reliable guide.

We thank the IGETC Standards authors for this fine document, which supports our work toward facilitating efficient transfer, expediting time-to-degree, and bringing the baccalaureate within reach of more Californians.
