- a. Review Minutes
 - i. 1st motioned by A. Reuss, 2nd by T. Le, T. McGrath (Abstain). Approved.
- b. Review Additions to the Agenda

- II. IELM Process J. Baker & J. Smith
 - a. J. Baker gave an overview of the history of Instructional Equipment and Library Materials (IELM) funding and provided a summary of past amounts received. Funds have not been received since 08-09.
 - b. J. Baker & J. Smith reviewed the past process for allocating IELM and VTEA. Discussion was held.
 - c. J. Smith gave a presentation on historical library funding.
 - d. M. Fritch provided information on the Perkins (VTEA) funding process, past and present. Discussion held on requests made for Perkins funds but not funded by Perkins.
 - e. Discussion was held on expected IELM amount (estimated at \$180,000) and timing of funding.
 - f. J. Baker gave an overview of the status of Program review
 - i. There were 77 Program Reviews which will take several days to go through.

 - g. T. McGrath reviewed the dates of future meetings and led the discussion on options for process review this year, timing of Program Review data capture and data dissemination, the Dean review, BARC review, BARC prioritization, PIEC review, and submittal to Executive Cabinet.
 - i. Discussion was held on review options
 - ii. M. Fritch provided an option of breaking into small groups to rate the programs, and then coming together in the large group to tally scores
