- Last year goal 4 was modified.
- Question raised about whether there is a comprehensive list of equity initiatives at the College
- Question raised about clearer definitions of some of the topics in this document such as ISS and Pathways work
- Should we see Pathways as part of our equity work?
- Seems they are closely related to one another. Also important to make sure that these align with Mesa 2030
- View expressed that every initiative should be conceptualized as an equity initiative.
- View expressed that there is a difference between equity work and other work that is done with an equity focus. Perhaps we should keep this distinction more clearly in mind because otherwise, things blur together and become confusing, and we lose a sense of what exactly we are doing.
- What is the lens we are looking through vs. the actions we are taking?
