Matt and Lorenze (along with reps from Campus Police and Facilities) to start developing protocols for different types of incidences which will be consolidated into a manual.</li> <li>Frank and Dan spoke of the need to notify Cal-OSHA if an employee is taken away from campus with an injury. Also, Cal-OSHA form 301 must be completed within 7 days of the incident.</li> <li>Dan to give Matt the Cal-OSHA phone number.</li> <li>Rob Meyers asked if we can put the Biohazardous waste collections points on the campus map. Matt started that the current Biohazard waste collection points are in AHT, Science 3<sup>rd</sup> floor, Student Health, Athletic Trainer area, and Allied Health.</li> </ul>
