Injury Reports

Faculty:

- 6/26/19: Male faculty member was feeling light headed and had difficulty breathing. He had experienced dehydration 6 days prior and was given medication that causes dizziness. Medics were called on-scene and transported him to Sharp Memorial for further evaluation.
- 8/20/19: Female faculty became dizzy and lightheaded and walked out of her class, running into the hallway wall. She refused medical treatment and drove herself home.

Visitor:

• A visitor was participating in the world police and fire games "dodge ball" and injured his right shoulder. He declined medical treatment, but was later taken to Sharp Memorial by his colleague.

Student:

- 5/9/19: Female student experienced weakness and dizziness as she sat in class. She had not consumed food due to religious fasting. She refused medical treatment.
- 5/13/19: Female student tripped, fell and struck her head as she walked in the CE Building hall. The student has a history of medical conditions. Medics arrived on scene and transported her to Scripps La Jolla.
- 6/5/19: Female student became light headed and dizzy while participating in Active Shooter training. Medics were called on-scene and transported her to Kaiser Hospital.
- 6/27/19: Female student was experiencing abdominal pain during class. She went to the restroom and called her sister to pick her up. She refused medical services and went home with her sister.
- 8/5/19: Female student experienced a panic attack. She was with her husband and refused medical treatment.
- 9/10/19: Male student was sitting on a curb and flagged down a passing Police for assistance. He stated
 that he could not stand and his legs could not support him. Medics arrived and transported him to Sharp
 Memorial for observation.

Student Accidents

- 5/3/19: Female student was experiencing seizure symptoms. Staff notified SDCCDPD and medics arrived on scene. She was transported to hospital for further evaluation.
- 5/16/19: Female student was walking and heard a pop on her lower back. She immediately felt pain radiate from her right leg to her lower back and was not able to sit. Medics arrived on scene and transported her to UCSD La Jolla Hospital.
- 6/13/19: Male student hurt his lower back while removing 315 lbs. of weight at the Exercise Science Building. He was seen at Student Health Services.
- 6/20/19: Female student tripped outside of the MS Building, injuring her left foot. Student went home.
- 7/2/19: Female student was lifting weights and had a weight bar roll off onto her right knee. Student went to Sharp Urgent Care for evaluation

- 7/10/19: Male student dove for ball while playing beach volley ball and rolled on his right arm while extending it and also struck his left ankle. He went back to class.
- 7/22/19: Male student made contact with a soccer ball while practicing causing a strain on his left calf. He later sought medical treatment.
- 8/5/19: Female student was walking outside of Science Building and caught the corner of her shoe on the corner of the floor and jammed her toe, injuring her ankle and thumb. She went back to class.
- 8/19/19: Female student was walking and twisted her ankle while walking and texting. The pain was a 6 out of 10 scale. She went home.
- 8/20/19: Female student was running to her badminton class when her shoe stuck to the floor and caused her to twist her ankle. She drove herself home.
- 8/22/19: Male student staples his finger causing minor bleeding. Remained in class.
- 8/28/19: Male student was exiting his counselor's office and caught his finger on the door latch, causing a
 U shaped cut.
- 8/29/19: Female student struck her right index finger as her teammate passed her a ball. She remained in class.
- 8/29/19: Female student leaped over an obstacle in her exercise class missing her step and twisted her ankle. Remained in soccer field.
- 8/30/19: Female student was walking in front of I-400 Building and while distracted with her phone, she dragged her left #5 digit toe (pinky) on concrete, causing pain and swelling. Sought medical treatment.
- 9/3/19: Female student was driving in the parking lot and her right knee popped. Possible pre-existing condition.
- 9/5/19: Female student was in exercise class and threw a medicine ball upward, causing her to jam her right thumb on the landing.
- 9/5/19: Female student slipped on a water puddle outside of her class in MS Building, causing injury to her left arm and wrist. She was seen at Student Health Services.
- 9/10/19: Female student open the Business Building door and scraped her left foot. Student went home.
- 9/11/19: Male student fell off his skateboard in front of the A Building, facing the campus, hurting his right side and elbow. Student went to class.
- 9/11/19: Female student was walking her dog. Her dog picked up an object and as she attempted to remove it from its mouth, the dog bit her left index finger.
- 9/11/19: Female student got kicked outside of Alpaca Corral on her left thigh. She remained in class.
- 9/11/19: Female student received a small cut her finger with ceramic tooling, she remained in class.
- 9/16/19: Female student stepped on a pebble causing her to roll her ankle and fell on her knee in fron of the I-400 Building.
- 9/18/19: Female student placed her back pack on shelf in restroom by LRC and fell on another students head.
