

IV. GUESTS:

- A. Dean Tina Recalde & Professor Connie Renda: Health Information Management (HIMS) Pilot Baccalaureate Program (Mesa College Web Site Link: <u>http://www.sdmesa.edu/academics/bachelors-degree/</u>)
 - 1. The Board of Governors (BOG) for California Community Colleges gave 15 colleges in its system the opportunity to pilot Baccalaureate Degree programs.
 - a. Mesa College was selected to pilot a Baccalaureate Program for Health Information Management (HIMS).
 - HIMS was selected based on labor market data and the high annual salaries graduates can earn.
 - The first freshmen cohort started in the two-year associate degree Health Information Management (HEIT) program in fall 2015.
 - The fall 2017 freshmen class can select the four-year HIMS baccalaureate degree program.
 - The HEIT associate degree program is a special admissions program in which the students who apply first are accepted first.
 - Students who apply for the HIMS baccalaureate degree program are evaluated based on their grade point average (GPA) and other criteria.
 - The baccalaureate program students are working adults who requested that their classes are scheduled in the evening.
 - HIMS is the documentation of medical records and medical billing processes.
 - Inna Kanevsky asked how many upper division general education courses are offered online.
 - * Connie Renda reported some courses are hybrid and some are fully online.
 - Connie Renda said 4 unit courses and lab courses are 16 week classes and 3 unit courses are eight (8) week classes (1st & 2nd Sessions).
 - The program must meet an external evaluation with 150 curriculum competencies.
 - Terry Kohlenberg asked about program retention.
 - * Connie Renda reported the sophomore class has 32 students.
 - Connie Renda reported that some of our students are waiting for the program to be accredited.

- Connie Renda said some of our students do not want to take courses that are part of the CSU GE Breadth or Intersegmental GE Transfer Curriculum (IGETC).
 - * The fall 2017 freshmen class will have to complete courses that meet CSU GE Breadth and IGETC requirements.
 - * Toni Parsons reported the CSU GE Breadth Pattern of courses has been approved for the HIMS program.
- Connie Renda reported the program courses will be evaluated in Program Review.
- Dean Tina Recalde reported Faculty members in the program will be required to teach our courses in a way that meets the requirements established by the external accreditor.
- Dean Tina Recalde said issues regarding courses in the program will be addressed through the Program Director and then the Department Chair.
- Connie Renda reported the program does not have a Foreign Language requirement, but the Spanish Medical Terminology course is recommended.
- Connie Renda also reported the external accrediting agency requires that Cultural Competency is embedded in each HIMS course and 14 out of 16 program students are already working in the healthcare field with diverse client populations.
- Holly Jagielinski reported the HIMS program has an Ethics course.
- Manuel Velez said Cultural Competency must be a part of all Public Service Fields.
- Connie Renda said new jobs have been created in the past 10-15 years that need to be filled by HIMS professionals in the private and public sectors.

 - A. Resolution 17.3.1 Priority Registration for Student Athletes: Jim Fegan/Henry Browne (Second Reading)

- 1. Friendly Amendment:
 - a. Resolution Mover Toni Parsons agreed to accept the friendly amendment to the ninth "Whereas" changing the word "needs" to "program'
- 2. <u>Current Students with Tier 1 Registration Priority</u>: (Proposal Provide Tier 2 Priority for <u>400</u> Student Athletes.)
 - DSPS Students (Dawn Stoll reported Mesa College has approximately <u>1,400</u> DSPS students.)
 - EOPS Students (EOPS Director Monica Demcho reported Mesa College serves <u>7</u>50 EOPS students)
 - Former Foster Youth (Monica Demcho reported Mesa College serves <u>25</u> Former Foster Youths.)
 - Student Veterans (Anthony Reuss reported Mesa College has approximately <u>2,800</u> Student Veterans.)
 - Vice President of Instruction Tim McGrath reported Mesa College's student enrollment is <u>22,931</u> via email to Academic Senate President Rob Fremland on April 18, 2017.

3. <u>Arguments for the Resolution</u>:

- a. Exercise Science Acting Dean Kevin Hazlett reported Exercise Science Faculty go out into the community and work with student athletes and their parents to bring the student athletes to Mesa College who may not be able to attend college otherwise.
- b. Exercise Science Chair Ed Helscher reported California Community College student athletes have regulatory requirements from groups outside their community colleges such the National Collegiate Athletic Associate (NCAA).
 - Student Athletes need to transfer from Mesa College in two-years in order to still have two-years of eligibility to play for a four-year institution.
 - It takes many students athletes three years to graduate from Mesa College and many are only on the practice squad for one of the years because they cannot enroll in the classes they need.
 - Four-year institutions have registration priority for their student athletes.
- c. Howard Eskew said it is important to realize that student athletes also receive scholarships to attend Mesa College and student athletes also have "equity" needs.
- d. Student Athletes Counselor Christina Carson reported student athletes have to meet more requirements than non-athletes to transfer to four-year institutions.
- e. Terry Kohlenberg supports the resolutions since other students already have registration priority.

f. Lauren Wade said student athletes are obligated to attend practices during certain days/times, which prevents them from enrolling in classes during those times.

4. <u>Arguments against the Resolution</u>:

- a. Carlynne Allbee said the football coaches never contact her about their players who are enrolled in her classes.
- b. Becca Arnold said about three fourth of her students also have problems getting the classes they need.
- c. Paul Sykes supports alternating registration priority for all students each semester.
- d. Helen Greenbergs asked if there are still seats available in classes for students who do not have registration priority.
- e. Inna Kanevsky reported she spoke to her department Faculty and her students.
 - Her students who are not athletes do not feel it is fair for student athletes to have priority registration before other students.
 - Student athletes have opportunities that are not available to non-athletes.
- f. Paul Sykes said there are other students with "equity" needs who are not receiving assistance and cannot enroll in the classes they need.
 - There are non-athletes who also need to complete classes in order to meet the requirements of their scholarships.
 - We schedule very few BIOL classes and labs and they fill up very quickly.
