## VI. ROUND TABLE TOPIC: Distance Education (Academic Senate President Rob Fremland)

- **A.** The Mesa College Curriculum Review Committee (CRC) and the district Curriculum Instructional Council (CIC) review all Mesa College proposals for a Distance Education component.
- **B.** Senate President Rob Fremland reported the other CA Community Colleges Academic Senate Presidents who are active on the list serve do not have official Distance Education policies for their colleges.
- **C.** Jonathan McLeod said it is the Academic Senate's prerogative to evaluate Curriculum Balance (% online vs. % face to face) (Equity vs. Growth) for the San Diego Community College District (SDCCC).
  - 1. Jonathan reported that he read a study that reported African American and Latino American students have lower success rates when they take general education courses online.
  - 2. The question is what is a reasonable percentage of online classes that we should offer?
  - 3. Jonathan spoke to Chancellor Carroll on Friday and the Chancellor would like to be part of the solution.
- **D.** Joe Safdie said Kat Gustafson (Dean of Online Education) reported 34% of classes offered statewide are online.
  - 1. 14% of SDCCD classes are scheduled online.
  - 2. Dean Gustafson told Joe that we are increasing the number of online and face to face classes equally.
- **E.** Thekima Mayasa asked, "How does increasing the number of online classes impact each program's graduation success rate?"
- **F.** Toni Parsons reported that programs with 50% of the units required for graduation online must be included in the Substantive Change Report for Distance Education.
  - 1. Mesa, City and Miramar each propose a Distance Education component for a particular course separately and approvals are delineated separately on the Substantive Change Report for Distance Education by college.
- **G.** Curriculum Review Committee (CRC) Faculty Co-Chair Paula Gustin said each Discipline Dean needs to take a leadership role.
  - 1. Paula will ask the CIC to remind our current Discipline Deans to hold regular meetings with their Faculty.
  - 2. Rob Fremland reported Dean Saied Eidgahy is the Math & Natural Sciences Discipline Dean.
  - 3. Rob Fremland and Kim Perigo would like to hold Faculty Discipline meetings in the spring semesters.
- **H.** John Crocitti said online classes are held to valid professional standards and we need to find out if we need to schedule more online classes when enrollment for face to face classes drop.
- **I.** Becca Arnold and Paul Sykes agreed that we should not establish a specific percentage number for all departments since each discipline is different.
- **J.** Helen Greenbergs said we need to look at the individual success rates for each discipline.
- **K.** John Crocitti said Evaluators need to receive the training that allows them to adequately evaluate Faculty who teach online courses.

## L. Action Plan:

- 1. Academic Senate President Rob Fremland will ask Chancellor Carroll to hold Discipline meetings.
- 2. Jonathan McLeod and Joe Safdie will develop an Academic Senate statement regarding Distance Education.
- 3. Toni Parsons asked CRC Faculty Co-Chair Paula Gustin to ask the CIC to call for a Disciplines Dean meeting since the CIC oversees the Discipline Deans.
  - a. Dean Shelly Hess held a Discipline Deans meeting at Mesa College a few years ago.

#### VII. OLD BUSINESS:

**A.** Institutional Learning Outcomes (ILOs): Academic Senate President Rob Fremland (Item was Tabled)
The proposed ILOs were adopted by the Committee on Outcomes and Assessments (COA) on May 17, 2016.
(No other bodies have approved the proposed ILOs.)
Motion to un-table the item:

- 1. Professor Kris Clark reported the COA was charged by the Planning and Institutional Effectiveness (PIE) Committee to rewrite the ILOs last year.
  - a. The proposed ILOs were presented during the spring 2016 convocation.
  - b. We had too many ILOs before. (They were redundant.)
  - c. The proposed ILOs are based on the Talk Sessions that occurred two years ago.

- d. We have grant money to pay departmental ILO Coordinators to complete the mapping in spring 2017.
- e. The Academic Senate approved the Faculty members who served on COA during the development of the proposed ILOs.
- f. Each department needs to map one course to one proposed ILO by October 15, 2016.
  - The data is needed to redesign the TaskStream Platform.
  - The Senate Exec will confirm/clarify the assessment requirement and due date.
- 2. Bill Brothers said course assessment will always be the same. (We also did not have enough time to assess courses in the past.)
- 3. Helen Greenbergs said that she feels rushed, which is creating a sense of resistance.
- 4. Inna Kanevsky said the current approved ILOs are more measurable than the proposed ILOs and we need more time to develop new ILOs. (The current approved ILOs are not accessible on the web site.)
- 5. Thekima Mayasa says a three-year cycle is not long enough.
- 6. John McLeod asked if he will be able to work with the Faculty ILO Coordinator to make sure his current department level ILOs are appropriate.
  - a. Kris Clark said she can work with Jonathan.
- 7. Dina Miyoshi said we are still unclear about the reason that the ILOs have to be changed right now and asked if mappings of the current approved ILOs are still available in TaskStream.
  - a. Kris Clark reported the current ILOs mappings are still available
- 8. Toni Parsons said a three-year cycle is not enough time to map 27 Mathematics courses. (We need a semester for reflection and we should not start a new process in the middle of the semester.)
- 9. Joe Safdie said we need a "Year of Reflection" to find out if things are working.
