

V. OLD BUSINESS:

- A. Resolution 17.10.1 Compensation for the American Federation of Teachers (AFT) President: (Perigo)
 - The AFT President attends meetings throughout the summer semesters and responds to calls and emails from union members.
 - 2. Jonathan McLeod reported the AFT President is a San Diego Community College District (SDCCD) employee with 100% reassigned time.
 - 3. Rob Fremland said we are supporting opening discussion only. (We are not negotiating.)
 - 4. Carlynne Allbee said Lou Ann Gibson reported during a previous meeting that the current AFT President said AFT does not support increasing salaries via a resolution and that she did not receive a response from Jim Mahler when she tried to contact him during the summer. (Carlynne also said the AFT President would receive a 20% raise.)
 - 5. Toni Parsons said the resolution is position specific (AFT President) and not person specific.
 - 6. John Crocitti said the Academic Senate should not increase pay for individuals through resolutions.
 - 7. Evan Adelson said this resolution will apply to more Faculty members.

VII. ROUND TABLE TOPICS:

A. AB 705: Toni Parsons

- 1. Students cannot be forced to take remedial MATH, which means we cannot have prerequisites.
- 2. Institutions are required to make sure students complete transfer level Mathematics in one year.
- 3. Toni Parsons said it takes some Mesa College students four semesters to complete transfer level Mathematics courses.
- 4. Mesa College will only have Intermediate Algebra, which is one level below transfer.
- 5. Science/Technology/Engineering/Mathematics (STEM) students will complete a different Mathematics requirement than non-STEM students.
- 6. Evan Adelson asked Toni Parsons if she agrees that Mathematics placement tests are inaccurate.
 - a. Toni said she agrees.
 - b. Toni also said that she can assess students by interviewing them.
 - Manuel Velez said assessing students using an interview process is called "Guided Placement".
- 6. We also have a retention problem.
 - a. Academic Senate President Kim Perigo said we need to investigate why we are losing students.
- 7. Paul Sykes said they are pushing a "one size fits all" model.
- 8. John Crocitti said the Academic Senate should not be involved in AB 705.
- 9. Toni Parsons said the Mathematics Department wants our student to be able to take non-transfer level Mathematics.
- 10. Toni Parsons also said the GI bill does not pay Veteran Students for course repetition.
- 11. Carlynne Allbee asked Toni Parsons if AB 705 only impacts transferring students.
 - a. Toni Parsons said removing prerequisites does not remove Title 5 language.
- 12. Wendy Smith said more than 75% of our students state that they want to transfer to four-year institutions.

B. Guided Pathways (GP): Academic Senate President Kim Perigo

- 1. Academic Senate President Kim Perigo reported GP was put forth by the California Board of Governors (BOG).
- 2. BOG members are appointed by the Governor.
 - a. BOG has very few members that are educators. (Members who are educators represent the Academic Senate for California Community Colleges (ASCCC).
 - b. BOG hired the current State Chancellor for the California Community Colleges system.
 - BOG gave the new State Chancellor an edict.
 - c. BOG is not prescribing one single/specific GP.
- 3. GP is not a fad and it has tremendous steam across the United States that will most likely last for the next two decades.
- 4. AB 1725 lists the 10+1 items that are under the purview of local Academic Senates and their Faculty members.
 - a. The Mesa College Academic Senate can make recommendations, but they do not have to be adopted by the Mesa College President or the San Diego Community College District (SDCCD) Board of Trustees (BOT).
- 5. GP has four pillars:
 - a. First Pillar: Clarify Path
 - Current Mesa College Programs are Career Education Pathways, Placement Assistant and San Diego Promise.
 - b. Second Pillar: Enter the Path
 - Current Mesa College Programs are Cruise and Legacy.
 - c. Third Pillar: Stay on the Path
 - Current Mesa College Programs are Puente, The Stand, STEM Conexiones, Tutoring and Umoja.
 - d. Fourth Pillar: Ensure Learning
 - Current Mesa College Programs are Mini-Grants and Professional Learning.
- 6. Julie Bruno of the ASCCC Teaching and Learning is the largest area that each community college focuses on.
- 7. Kim Perigo said Faculty always has a list of additional items they feel their students need.
- 8. Faculty needs to develop a thoughtful approach.
- 9. The ASCCC fall 2015 Resolution 19.02 supports local development of curricular pathways.
- 10. The ASCCC fall 2016 Resolution 19.03 investigates effective practices.
- 11. We want to reduce the Equity Gap.

- 12. Are our students able to enroll in the classes they need at the times they need?
- 13. We want to make sure that we protect all our programs.
- 14. Rob Fremland said the Academic Senate and our colleagues need to drive GP and we need to look at research that helps us find ways to improve learning.
- 15. Helen Greenbergs said the authors of the fall 2017 Mesa Reads book that GP is based on "Redesigning America's Community Colleges: A Clearer Path to Student Success" admits that there isn't a lot of data regarding GP.
- 16. Holly Jagielinsk asked how will we show progress during the next 20 years. (Healthcare needs better measurements.)
- 17. Bruce Naschak said we need to be vigilant and discuss new information about GP during every Academic Senate meeting.
- 18. Shannon Shi asked who will work on GP.
 - a. Kim Perigo said the college has to decide if it will be the Academic Senate, Committee of Chairs, a new Academic Senate subcommittee or a new separate committee.
- 19. Wendy Smith said there has been a grassroots GP movement during the past few years and AB 705 will be a good thing for our students.
- 20. Paula Gustin said our students need to know what they need to do to transfer to four-year institutions and we need out Counselors to help our students.
- 21. Inna Kanevsky said we need to look out for "Confirmation Bias" when we research GP.
 - a. There are big differences in outcomes research.
 - b. Kim Perigo said we do need to be vigilant about the research we are accessing.
- 22. Kim Perigo said GP is no longer voluntary.
