B. Tonya Whitfield – Credit for Prior Learning (CPL) Updates:

As reported by Tonya Whitfield:

"Follow-up on CSU and UC question

**CSU is accepting all forms of CPL

***UC is only accepting credit by exam – must be a course listed in the catalog, UC transfer course, posted to a specific term, specific units and grade

***UC must be taken in sequence

***Direct all UC bound students to counselors for guidance

***UC is not accepting any industry certifications or portfolios

***UC is due to review and revise their position on CPL, expected June 2024

Cpl types:

- Credit by exam
- Military JST
- Portfolio
- Industry certificate

Credit by exam - approved by faculty list of courses that students may apply to receive credit for a course by completing an exam

- SDCCD cpl
- Curriculum approved in past years all 3 campuses must approve that the course is appropriate for credit by exam
- Does not have to be offered at all campuses
- If already at one campus, it can be added to a campus thru CIC/CRC
- Curriculum voted several years ago that all campuses have the individual right to not offer CBE. This is why the exam for the course is to be held at the campus level not district level.
- Future discussions about creating a repository for exams that are on the approved list

Military JST

- Joint service Transcripts
- Complete record of all Military training and schools with course descriptions and unit hours
- ACE Military Guide American Council on Education
- ACE provides connections from Military training to college courses
- MILPMAP New platform designed to make connections from Military training to college courses (State Chancellor partnering with MILMAP, still in testing)
- Portfolio is being used as a way to assess a compilation of Military training and experience to award credit
- Discipline Faculty are the only person/s that have final approval for any awards whether through JST/ACE/MILMAP/Portfolio
- 2 of 3 must approve the course connections for it to be listed on the approved list and course of record

Portfolio

- various Portfolio Options
- Based on course design
- Not applicable for all courses
- Can be compilation of work history, letter from current employer and past employers on job descriptions and duties, oral presentations, Portfolio book, etc.
- Discipline faculty are the only person/s that can approve and create the rubric for assessment
- Palomar is using this assessment to award most Military with credit.

Industry certification

- Certain courses are connected to particular certifications
- If a student holds the certification already, it may be used to clear that course and to allow the student to continue to the next level course/s
- District has a current list of Industry certifications that are approved
- In CurriQunet Meta Industry certification can be added with the name and/or code to identify the correct certification acceptable to clear the course requirements
- Pass/no pass vs grade
- Pass/no Pass is the only option for grade unless the certification comes with a percentage to use when assigning the grade

Fall 2024 goal

• Review the list of courses on the district approved list for accuracy with lead/discipline faculty – click on the approved course search below an look at your program's approved courses. Compare them to the other campus offerings.

Approved course search

- Identify courses with industry certification that may be considered for cpl
- Work with chairs and lead faculty to determine if courses at Miramar and/or City College may be considered to be added to Mesa's approved list
- Continue the conversation and education on the advantages of CPL
- Remember the goal of CPL is to award students credit for work experience, training and knowledge that they already have. By awarding credit for prior learning, we are promoting student success and allowing them to move forward with their education and career goals.
- CPL will not be for everyone. It is designed for specific students in mind.
- Lead discipline faculty always have the final approval

- Please remember even though it is a lot of work in the beginning, it can be streamlined to be a simple process with a solid foundation by putting the effort in the beginning
- Students that are applying for CPL are putting just as much effort in to applying and completing the process as us (faculty, counselors, evaluators, curriculum committees, administrators)
- Even if you are not 100% sure your program has CPL opportunities, be willing to at least discuss the possibilities and potentially the advantages to your program and the students, your students
