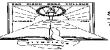

- The district task force was created because the cost of textbooks is a significant issue for our students. 2.
- The current average cost of a textbook for a Mesa College Student is \$60.00. 3.
- 4. Textbook costs can determine whether a student enrolls in a class or drops a class.

- 5. 80% of students surveyed reported their Instructors do not use the required textbook.
  - a. ASG Representative Clairine Wantah reported one of her instructors is not using the required textbook this semester.
  - b. The survey does not define what "Using the Textbook" means.
- 6. Some students have to choose between buying textbooks or buying groceries.
- 7. Rob Fremland asked Faculty to review their textbook lists for accuracy.
- 8. There will be a designation in Campus Solutions for courses with "Zero Textbook Costs".
- 9. Librarian Lisa Burgert reported she received grant funding to purchase "Open Stack" material that can be reviewed by the departments.
- 10. Learning Resources Department Chair Alison Gurganus reported Faculty must remove their textbooks from the Reserved Section of the Library at the end of each semester to prevent Copyright Infringements.
  - a. Faculty can put their textbooks right back in the Reserved Section of the Library for the next semester.
  - b. Access to a Reserved Textbook helps reduce costs for our students.
- 11. The San Diego Community College District (SDCCD) Board of Trustees (BOT) currently has the goal of having 15% of our courses using <u>only</u> OER materials in two (2) years.

# BP 5020 CURRICULUM DEVELOPMENT DRAFT

# References:

Education Code Sections 70901(b), 70902(b), and 78016; Title 5- Sections 51000, 51022, 55100, 55130, and 55150; U.S. Department of Education regulations on the Integrity of Federal Student Financial Aid Programs under Title IV of the Higher Education Act of 1965, as amended; 24 Code of Federal Degulations Sections 600.2, 602.24, 602.24, and 668.8;

34 Code of Federal Regulations Sections 600.2, 602.24, 603.24, and 668.8; WASC/ACCJC Accreditation Standards II.A and II.A.9

The courses, degrees, and certificates of the District's Colleges and Continuing Education shall be of high quality, relevant to community and student needs, and evaluated regularly to ensure quality and currency.

The Chancellor shall develop procedures for the approval of all courses of instruction and of all educational programs regardless of delivery modality that satisfy the requirements of the Education Code and the California Code of Regulations, title 5. The procedures for the development and review of all curricular offerings, including their establishment, modification, or discontinuance shall remain flexible to permit timely response to change.

Furthermore, these procedures shall assure:

- I. The Colleges and Continuing Education faculty and Academic Senates assume primary responsibility for making recommendations in the areas of curriculum and academic standards.
- II. The Colleges and Continuing Education curriculum committees are recognized as the primary decision-making bodies that offer recommendations regarding courses, degrees, and certificates to the Curriculum and Instructional Council (CIC), the Board of Trustees, and the California Community Colleges Chancellor's Office, as appropriate.
- III. Regular review of courses, degrees, and certificates.
- IV. Training opportunities for persons involved in aspects of curriculum development, and

# Mathematics Competencies Requirement Recommendations

"Competency in mathematics" means the ability to analyze and reason quantitatively and solve problems using concepts at the level of intermediate algebra or higher. Courses that meet the math competency requirement have a substantial component involving mathematical reasoning. # SDCCD Additional College Degree

A student having received an associate or baccalaureate degree may qualify for an additional Associate of Arts or Associate of Science degree.

An additional degree:

**1.** Permits upgrading or preparation for upgrading current employment.

2. Prepares for employment in an area different from that provided by previous training.

**3.** Provides general knowledge leading to fulfillment of personal goals.

**4.** Allows the student to improve priority of transfer applications by earning an Associate Degree for Transfer (ADT).

The following requirements are applicable:

A student must earn a minimum of 6 required semester units in the new major or emphasis. A minimum of 12 degree-applicable units must be completed in residence at the college granting the degree.
 A student must fulfill current catalog associate degree requirements.

**3.** In order to receive an additional college degree, the student must file a Petition for Graduation in the Evaluations Office. Counselors will review all previous college work to determine the student's eligibility for a second degree.

ADT Exemption: Students who have previously been awarded an Associate Degree and wish to receive an ADT will be exempt from the additional unit requirement of 6 new units. Students who wish to pursue a second ADT in a new major will also be exempt from the additional unit requirement of 6 units in the major. Students must complete all required courses for the ADT and submit a graduation petition for the new degree. Upon approval, the additional ADT will be posted to the student's academic record.

A student who has earned an ADT and returns to earn an additional AA/AS (non-ADT) degree must have at least a 6-unit difference in the major.
