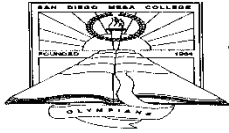

- Carlyne Allbee reported she attended the 2019 Faculty Association for California Community Colleges (FACCC) Advocacy and Policy Conference and keynote speaker Hank Reichman spoke about all levels of higher education and reported his committee is working on extending Tenure to Adjunct Faculty Members who have seven (7) years of service.
 - Jonathan McLeod provided the following response: As reported by Jonathan McLeod
"I was not present at the meeting you attended and so I did not hear the *actual* language used relative the proposal on "tenure" for adjuncts on which you have reported. However, I must point out, as the AAUP and FACCC are well aware, that tenure is not awarded based simply on years of service. In universities, the average time for assistant professors to come up for tenure review is six to eight years; for the California Community Colleges, the Ed Code mandates that the decision is made during the fourth year. Evaluations of faculty under review properly are extensive and intensive. In the case of the SDCCD, assistant professors who are promoted to the rank of associate professor, with tenure, have been judged as meeting the Standards for Tenure and Promotion (CBA. Art. 8.A.4.6 and Art. 8.A.4.7). The review process for adjuncts, by comparison, is limited."

1. Academic Affairs Committee: Chair Howard Eskew
 - a. Academic Affairs Subcommittees:
 - The committee is reviewing our subcommittees to ensure that Academic Affairs is the appropriate committee for the needs of our current subcommittees.
 - b. The Proposed Fine and Performing Arts Committee:
 - Chair Judy Sundayo the Committee for Diversity Action, Inclusion & Equity (CDAIE) will vote on the proposal to make the Fine and Performing Arts Committee a part of CDAIE.
2. Professional Advancement Committee (PAC): Chair Janna Braun (No Report)
3. Committee of Chairs (COC): Chair of Chairs Terry Kohlenberg (2 Minutes)
 - a. The Chairs met with Vice President of Instruction (VPI) Isabel O'Connor regarding Enrollment Management.
 - The VPI seems to be willing to listen to what the Chairs have to say.
 - b. Mesa College is on track to meet our enrollment goals.
 - c. The new California Funding Formula has changed everything.
5. Curriculum Review Committee (CRC): Faculty Co-Chair Andrew Hoffman
 - a. Liberal Arts and Science Degrees Review and Clean-Up:
 - Faculty seems to be reluctant to deactivate degrees programs that very few students select as their major.
 - There are degrees that are awarded to less than ten students in a five year period.
 - We also currently offer more than one of the same degree.
 - We will not delete degrees unless we receive agreement from Faculty.
 - Andrew would like to receive comments from Department Faculty Members.
 - b. Students Earning More than One Degree: On last Curriculum Instructional Council (CIC) Agenda
 - Currently, SDCCD students must return the Associates Degree they already earned before they can receive an Associate Degree for Transfer (ADT).
 - Please ask your Department Faculty if they would like to change the current requirement that students must earn 18 "distinct" additional units before they can earn an additional degree. (We need to review what "distinct" means.)
 - Counselor Anthony Reuss said too many students already earned enough units to receive another degree and our college receives funding for each degree we award.
 - c. Automatic Awarding of Degrees:

- Andrew provided a printout with the current policies at other community colleges for Automatically Awarding of Degrees.

6. **Program Review Committee (PRC): Faculty Co-Chair Bruce Naschak**

As reported by Bruce Naschak:

- The IE administrative office submitted questions to include in the Program Review modules for this year.
- Bruce Naschak and Jonathan McLeod noted that some of the questions were confusing and repetitive.
- Academic faculty on the committee revised the proposed format and questions to try to make them more effective.

C. Other Committees:

1. **Committee for Diversity Action, Inclusion & Equity (CDAIE): Chair Judy Sundayo**

As reported by Judy Sundayo:

- * Along with the Black Studies Dept., the English Dept., the Art History Dept. and the UMOJA program, CDAIE co-sponsored more than 17 successful activities for **Black History Month** in February, attended by over 350 students, faculty and staff
 - * March is **Women's History Month** and there are a number of exciting activities coming up this month, including **"Complicating a LATINX Identity with Dr. Gina A. Garcia** on March 14th, the **HSI Conference** on March 15th and the **8th Annual Gracia Molina de Pick Feminist Lecture Series** on March 20th & 21st
 - * The Cultural Events Calendar will be disseminated soon
 - * **Cultural Unity Week** will take place April 8 – 12th with the **Festival of Colors** taking place on Thursday, April 11th, from 10am – 3 pm, where there will be drumming and dancing outside of the Commons. ***Be prepared for drumming!***
 - * CDAIE has been working with the Student Diversity Club to sponsor the **Annual Student Diversity Club Luncheon** on Friday, April 12th from 12 – 2 pm in the Osani Circle.
 - * CDAIE is collaborating with the LRC to prepare a FLEX workshop on **Student Success & Equity in the Library**. The dates are April 12th, 19th & 26th from 9:30 – 11:30 in LRC 432
 - * CDAIE has been in communication with the Academic Affairs Committee regarding the possibility of some of the committees, which traditionally have reported to AAC, to be re-housing under CDAIE, i.e. if those committees agree that it would be a better fit. Dina Miyoshi spoke to CDAIE last Friday about this and the request from the **Fine & Performing Arts Committee** to be housed under CDAIE. The committees involved are currently reviewing options and establishing parameters for what this restructuring would entail.
 - * CDAIE members have been in discussion with administration with regard to the **CDAIE budget** and how monies are disseminated. During the next academic year, CDAIE will create a process for requesting proposals for small grants of money to support the many events on campus that support diversity, equity, inclusion and inter-cultural understanding. If any department needs an honorarium for a speaker or money for a performer or for a presentation that supports CDAIE goals, please inquire as there may be limited funding available.

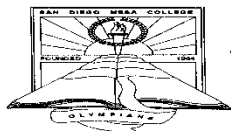

A. DRAFT 2019-2022 Mesa College Technology Plan: Momilani Ramstrom & Duane Wesley

Mesa Information Technology (MIT) Committee:

1. Momilani Ramstrom and Duane Wesley encouraged the Senators to review the draft plan and provide their feedback.

a. The feedback will be shared with the MIT Committee.

b. Momilani Ramstrom will update the draft plan to include feedback she receives by April 4th.

2. The MIT Committee would like to get a sense that the Academic Senate supports the draft plan during the April 8th meeting.

3. Duane Wesley reported the draft plan is a snap shot of Mesa College's current technology infrastructure.

4. The Mesa College Technology Plan is updated every three (3) years.

5. Departments submit funding requests for technology needs in their Program Review.

a. The Budget Allocation of Resources Committee (BARC) reviews the funding and approves or denies the funding requests.

6. Duane Wesley said the MIT Committee can bring up failures to approve funding requests for technology.

B. Resolution 19.3.1: Response to CSU General Education Task Force (GETF) Recommendations: John Crocitti

1. John Crocitti reported the CSU created the GETF in 2016.
 - a. Jonathan McLeod reported the purpose was to streamline General Education (GE) requirements.
 - b. The task force met in secrecy.
 - San Diego State University Faculty reported that they were not permitted to attend GETF meetings.
2. The CSU GETF is recommending that the number of required American Institutions units be reduced.
 - a. The recommendation impacts Black Studies, Chicano Studies, History and Women's Studies and may also impact Humanities courses.
 - b. Bruce Naschak said this sounds like Guided Pathways.
3. The CSU GETF's recommendations need to be vetted throughout the entire CSU system.
4. John Hoskins and Inna Kanevsky provided amendments to the resolution.
5. The resolution asks the Academic Senate for California Community College (ASCCC) to create a resolution that opposes the CSU GETF recommendation to reduce the number of units for American Institutions GE requirement.

BP 5020 CURRICULUM DEVELOPMENT DRAFT

The courses, degrees, and certificates of the District's Colleges and Continuing Education shall be of high quality, relevant to community and student needs, and evaluated regularly to ensure quality and currency.

The Chancellor shall develop procedures for the approval of all courses of instruction and of all educational programs regardless of delivery modality that satisfy the requirements of the Education Code and the California Code of Regulations, title 5. The procedures for the development and review of all curricular offerings, including their establishment, modification, or discontinuance shall remain flexible to permit timely response to change.

Furthermore, these procedures shall assure:

- I. The Colleges and Continuing Education faculty and Academic Senates assume primary responsibility for making recommendations in the areas of curriculum and academic standards.
- II. The Colleges and Continuing Education curriculum committees are recognized as the primary decision-making bodies that offer recommendations regarding courses, degrees, and certificates to the Curriculum and Instructional Council (CIC), the Board of Trustees, and the California Community Colleges Chancellor's Office, as appropriate.
- III. Regular review of courses, degrees, and certificates.
- IV. Training opportunities for persons involved in aspects of curriculum development, and

Multiple Degree Examples

MiraCosta

Multiple Degrees Students who are in progress to complete or who have previously been awarded a MiraCosta associate degree may be qualified for an additional associate degree under the following circumstances: The additional degree represents a new major. Each degree has at least 12 mutually exclusive units. All degree requirements have been met including residency, with at least 12 units completed in the new major, at MiraCosta College. Students may earn multiple degrees concurrently provided the above criteria is met.

Southwestern College

Multiple Degrees

Students who qualify may receive additional associate degrees provided the designated degree to be earned will represent a change in major from the degree or degrees previously earned. A student who has already earned a bachelor's or higher degree may qualify for an associate degree providing that the designated major is different from the bachelor's or higher degree.

For each additional degree, the student must complete all requirements for the new major with a minimum of 18 new units. The additional units must include a minimum of 12 units in the major. In addition, the student must meet all graduation requirements enforced at the time of declaration of a new major.

ADT Exemption: Students who have previously been awarded an Associate Degree and wish to receive an ADT will be exempt from the additional unit requirement of 18 new units and 12 units in the major. Students who wish to pursue a second ADT in a new major will also be exempt from the additional unit requirement of 18 units and 12 units in the major. Students must complete all required courses for the ADT and submit a graduation petition for the new degree. Upon approval, the additional ADT will be posted to the student's academic record.

A student who has earned an ADT and returns to earn an additional AA/AS (non-ADT) degree must have a 12 unit difference in the major and the additional 18 unit requirement.

SDCCD

Additional College Degree

A student having received an associate or baccalaureate degree may qualify for an additional Associate of Arts or Associate of Science degree in a new major or concentration.

An additional degree:

1. Permits upgrading or preparation for upgrading current employment.
2. Prepares for employment in an area different from that provided by previous training.
3. Provides general knowledge leading to fulfillment of personal goals.

The following requirements are applicable:

1. The degree to be earned must represent a change in major or concentration from the degree or degrees previously earned.
2. A student must earn a minimum of 18 required semester units in the new major or concentration beyond the minimum 60 units required for the Associate Degree, bringing the total units required for the second degree to a minimum of 78 units, a minimum of 96 units for the third degree, and so on. Twelve (12) semester units of the new major or concentration must be completed in residence at City, Mesa and/or Miramar.
3. A student must fulfill current catalog associate degree requirements.
4. In order to receive an additional college degree, the student must file a Petition for Graduation in the Evaluations Office. Counselors will review all previous college work to determine the student's eligibility for a second degree.

Palomar College

Additional Degree Information

Additional Associate Degrees Additional Associate degrees may be earned in other majors with the exception of General Studies and University Studies. Students may earn only one General Studies and one University Studies degree.

1. Students who have received an Associate degree, and maintained continuous enrollment, may pursue subsequent degrees by fulfilling the major or area of emphasis requirements.
2. Students who have received an Associate degree, but did not maintain continuous enrollment, may pursue a new major or area of emphasis under the catalog of readmission.

Having received an A.A. or A.S. degree in University Transfer Studies a student is not eligible to receive an additional University Studies degree at Grossmont College. C. Having received a Bachelor's Degree or higher, a student may qualify for an A.A. or A.S. Degree in other fields with the exception of the General Studies Degree or the University Studies Degree. D. Having met all general education requirements as specified in this catalog and completed a minimum of 12 units in the major at Grossmont College subsequent to the preceding degree(s), with the exception of an Associate Degree for Transfer (ADT).

Cuyamaca

Additional Associate Degree

An additional associate degree may be earned under the following conditions: A. Having received an associate's degree or higher, the student will not receive an AA or AS degree in the same area, unless the field is broad enough that the new courses would not be a repetition of content from previous education. B. All General Education requirements as specified by the current catalog are met. C. Completion of a major as specified in this catalog with a minimum of 12 remaining required semester units in the major completed at Cuyamaca College subsequent to the preceding degree(s) at any college.

Napa Valley College

Multiple Associates Degrees Students can complete the requirements for more than one degree upon graduation, providing that all requirements are met for each academic program.

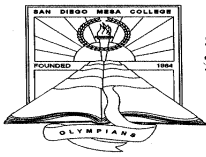
COURSE UNAVAILABILITY A student's academic progress toward a degree or certificate should not be impeded due to course unavailability. Therefore, if a course in a designated field of study has not been taught for three consecutive semesters, the Program Chair, or in her/his absence, the Division Dean, in consultation with the appropriate department representative, will stipulate another course in lieu of the course required for graduation.

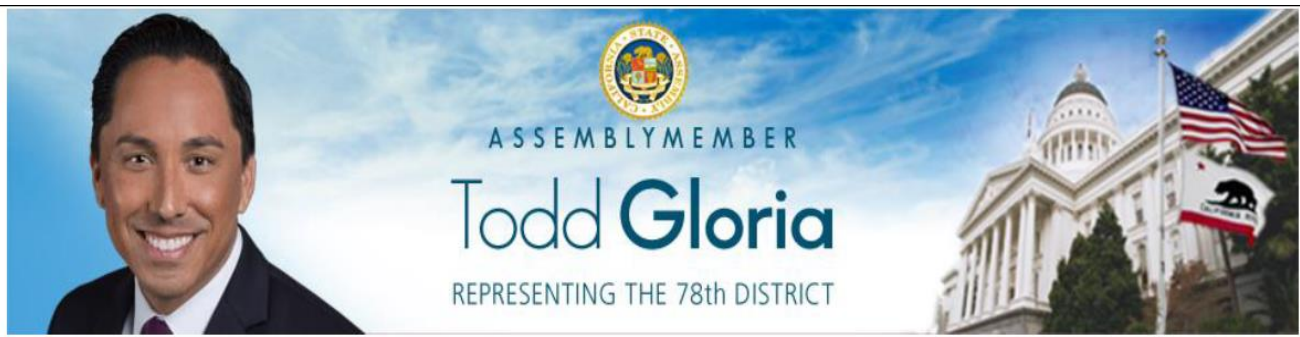

AB 1150: San Diego and Grossmont-Cuyamaca Community College Districts Election Reform

Summary:

This bill would require candidates for the Governing Board of the San Diego Community College District and the Grossmont-Cuyamaca Community College District to collect at least 100 signatures of voters in their trustee area in support of their candidacy in order to qualify for the ballot. No other Governing Board jurisdictions would be affected as these two Districts already have unique Ed Code provisions that pertain only to them.

Background:

In most large cities, School Board members are required to either pay a filing fee or produce signatures from the community that they are seeking to represent. For example, the San Francisco Community College Board requires 1,000 signatures in lieu of a \$500 filing fee. The San Diego Unified School District Board requires candidates to produce 100 signatures as part of their application for candidacy. Candidates for Statewide office in California require anywhere from 1,000 to 7,000 signatures to qualify for the ballot. However, in the Grossmont-Cuyamaca and San Diego Community College Districts, this is not the case. Any person who fills out the required paperwork is automatically added to the ballot, with absolutely no signature requirement or filing fee.

Collecting signatures is a common sense and democratic way to demonstrate community support and ensure that candidates running for these positions have at least minimal support in the districts they seek to represent.

This bill:

Specifically, this bill:

1. Requires prospective candidates for the Grossmont- Cuyamaca and San Diego Community

College Governing Boards to produce at least 100 signatures of registered voters in their Trustee area in support of their candidacy as a requirement to appear on the ballot.

2. Since this legislation would become effective January 1, 2020, it will apply to Governing Board elections beginning in 2022 since the filing period for the 2020 elections in these two Districts closes in December, 2019.
