As Reported by Judy Sundayo:

"CDAIE held its last meeting this semester on 12-6-24, with 21 persons attending.

The Committee joins the campus in recognizing World Aids Day (Dec. 1), International Day for People with Disabilities (Dec. 3), and International Human Rights Day (Dec. 10).

Leland Simpliciano announced the next AANAPISI Community of Practice training on Jan. 22-24, centering on the Asian American & Pacific Islander experience. Interested participants must apply by Dec. 13th.

FPAC announced Dance Vision Performances Dec. 5-7, Mesa music online Composition Dec. 10, and Mesa music jazz guitar, Dec. 10

Dora Schoenbrun-Fernandez reported on International Education, with Study Abroad coming in January in Argentina, summer in London, and summer in Kyoto. Proposals for 2026 Study Abroad are due March 7. Recommend developing your (MOU) now. In spring, focus groups will take place to increase study-abroad opportunities for our marginalized student populations. Collaborations have already begun with UMOJA, PUENTE, KAPWA, Honors, EOPS, and the Pride Center.

Lucio Lira announced an LGBTQIA+ Learning Community in the fall of 2025, with ENGL 101 and PERG 120. Also, the Pride Center is offering twenty-six \$500 scholarships for LGBTQIA students.

The Student Affairs Office announced the A.S. Student Leadership Retreat will take place on Jan. 28<sup>th</sup> at the Marina Village Conference Center.

The DEIA Discussion Guide completed its campus tour this semester. The Committee will follow up on responses from campus units in the spring.

Black History Month will kick off with the Annual Rosa Parks Birthday Recognition & Libation Ceremony on Wed. Feb.  $5^{th}$  at noon at the Rosa Parks Transit Station on campus.

The Student Diversity Club is working on a booklet entitled: 60 Ways to Discover Diversity at San Diego Mesa College, to be released in the spring.

The Professional Learning subcommittee reported that our Land Acknowledgment posters are now available. Individuals can pick one up from Dean Leticia Diaz in I4-401.

The Women's Advisory Committee is finalizing events for Women's History Month.

As reported by Andrew Hoffman:

"The President's Cabinet retreat was held on Tuesday, November 19. At the retreat, President Hands shared the 2023-2024 Annual Report. This 36-page document covered many items, including detailing our student demographics, our 5% growth, the first Powwow in over 20 years, the Mesa 2030 Strategic and Facilities Plan, and many other topics. The document can be found online on our Mesa website. Dr. Hands shared the upcoming fiscal outlook from the state's Legislative Analyst Office. The operative word in the report was "uncertain" – a word used repeatedly. Not a ton of optimism to be found. A government relations report was also included. Of most importance to us is that Measure HH passed with the required supermajority. Now, the bonds have to be sold, building priorities set, deferred maintenance projects assessed, and eventually work will begin. Don't expect anything too soon.

ALMA – the Alliance for Latine Mesa Achievement – has been created. A special shout-out to Toni Trejo Parsons for her hard work in making this happen as our HSI Program Activity Manager.

The Mesa Climate Survey results were presented. The report is also available on our Mesa website. What was disappointing is that in many of the surveys, Mesa lagged behind district average in terms of addressing employee concerns about discrimination and exclusion, based on such issues as race, gender, age, religious affiliation, and others. I encourage everyone to take a look at this survey on their own.

We also heard about the Puente Project, which has been on campus since 1989. Again, shout out to Patty Rodriguez (Counselor), Christie Allred (English) and Juan Bernal (Math) for their continued hard work and innovation. Puente, here and across the state, has made a positive impact on our students, showing higher than average rates of retention, success, and GPA.

We also got an update on Administrative services from Lorenze Lagaspi, addressing such varied issues like skateboarding, Wi-Fi, and hiring. On this latter issue, there will be a new workgroup, called the Contract Hiring

Process Review Group. This group will not just cover faculty hiring, but all full-time positions at Mesa College.

(This is NOT related to the district's experimental contract hiring process.) If you are interested in participating, please let Veronica Gerace or me know. They want to begin in January.

We also received a presentation from Hai Hong and Eliza Rabinovich, just as we did today here.

On other matters, if you are interested in being a Marshall at the year-end graduation, please let me know. We need two faculty to serve."
