#### ٧. **OLD BUSINESS:**

- A. Californian Virtual Campus (CVC): Moreno Ikari
  - 1. Proposal to List Course Modality on California Community Colleges (CCC) Student Transcripts Updates to SDMC AS Resolution 2022.11.1:
    - a. The SDMC AS approved Resolution 2022.11.1 Processes for the California Virtual Campus (CVC) on December 12, 2022.
    - b. SDMC AS President John Crocitti reported he is working with Rob Fremland to update SDMC AS Resolution 2022.11.1 to include a proposal to list course modality for each course listed on California Community Colleges (CCC) Student Transcripts.
    - c. SDMC's Academic Senate for California Community College's (ASCCC) Area D Representative Manuel Velez will introduce the updated resolution during the next ASCCC Area D meeting.
      - Our goal is for the Area D to forward the updated resolution to the spring 2023 ASCCC Plenary Session for review and approval.

- d. Knowing the modality of the course a Student completed is the only way that we can maintain our standards.
- e. Comment from Helen Greenbergs:

As reported by Helen Greenbergs:

"Regarding the discussion of concerns about online classes/the resolution to require transcript designation of online vs in-person classes - I suggested that when a discipline decides, based on their expertise, that a particular course shouldn't be taught online (nor given credit as transfer units if it was taken online elsewhere), that is not "blocking" students. That is ensuring that students have the appropriate preparation to be successful in future classes and/or jobs."

#### VI. NEW BUSINESS:

# **A. Spring 2023 Enrollments**: Moreno Ikari

- 1. Comments:
  - a. Helen Greenbergs:

As reported by Helen Greenbergs:

"Regarding the discussion of deans cutting low-enrolled classes, particularly several weeks before the start of the semester - I suggested that it would be a good idea to invite Isabel O'Connor to a Committee of Chairs meeting to discuss our concerns related to this practice."

#### b. Thekima Maya:

As reported by Thekima Mayasa:

- "I inquired on if the deans Counsel were aware of past practices where course were allowed to continue through the first week of classes before being cancelled for low enrollment. And that this should be considered moving forward.
- That honors coordinators and the honors counselor have confirmed that 12 week courses can be used for individual student honors contracts.
- That Black Studies participated in an evening course pilot program where a demand by student veterans for
  evening courses was said by counseling to be met. However, the course was cancelled die to low enrollment.
  Cynthia Rico was explaining that the wave of student seeking classes was similar to last fall in that they were
  attempting to add very late.
- I mentioned that admin need to consider how students relying upon financial aid in many cases don't get approved until late in the enrollment cycle. I gave an example of speaking to a studendent before coming to the meeting who had literally just been approved to add classes this morning, two days before the 16 week add deadline closed."

#### **A. Academic Affairs**: Odasso

# C. Curriculum Review Committee (CRC): Resch

As reported by Nathan Resch

"CRC reviewed a memorandum from the state chancellor's office regarding "Title 5 Emergency Withdrawal and Pass/No Pass". The state chancellor's office looked closer at rules related to executive orders instituted during COVID that could continue beyond the end of the COVID Emergency. The discussion did not provide clarity on whether the district is implementing the Chancellor's office recommendations which:

- Extends the Pass/No Pass selection option for students to the end of the semester (previously 30% of the time course scheduled). SDCCD courses pass/no pass options are currently in line with the withdraw date for spring 2023 courses (faculty noticed that this was the case for their courses).
  - o State Chancellor recommends local policies be updated to ensure equitable implementation.

VPI Isabel O'Connor provided an update on AB1111 analysis and planning in the her work as a Chief Instructional Officer representative on the Common Course Numbering Task Force. The task force created a document with ideas on how to start working on common course number for which she welcomes feedback. Please find document attached.

VPI O'Connor also provided an update on a region X discussion related to a backlog of articulation agreements that are not making their way into Assist along with other issues between region X colleges and SDSU. An agreement has been put in place to help alleviate the issues short and long term, which may include establishing 5 year articulation agreements rather than just 1 year.

Juliette Parker reported that resolutions and letters of support in retaining Area E within CalGETC have been produced by the Community College League of California CEOs and several other CEO regional groups. VPI O'Connor plans to bring this up at the region X CIO meeting. Juliette welcomes any other ideas on how to support the retention of area E, and keeping it as a lower division graduation requirement.

CRC voted to support a new subject indicator at Miramar Public Safety Management (PSMA) for which it was noted that this may be the new subject indicator for the proposed BA in public safety."

#### **D. Student Services**: Dougherty/Higginbotham/Rico

Counseling:

As reported by Cynthia Rico:

- "Madison High school will bring a contingent of 100 students to Mesa for Pre-enrollment presentations on February 24, 2023
- CE Day at Mesa and Clairemont High school will take place on March 15, 2023 (there will be a call out for those programs to table)

- Jump Start—Saturday March 11, 2023 (Mesa's Open House) An e-mail has been sent to the campus seeking participation
- More information forthcoming—Effective Fall 2023 –The district will allow students to retake a course which they are currently enrolled, however not successfully passing, can be manually enrolled (in admissions) to retake the course the following session prior to grades being posted. The student must receive a note from the instructor indicating that the student is not passing, additionally, the student will sign a form understanding if they do pass the course, they will be dropped from that class."

#### 2. <u>DSPS</u>:

As reported by Erika Higginbotham:

- "DSPS: We have Academic Facilitators available to support DSPS students who need some additional support with classes (study skills, mental health and wellness, technology support). Reach out to DSPS if you think you have a student who might benefit.

#### 3. <u>EOPS</u>:

#### J. President's Cabinet: Crocitti/Moreno Ikari

- A. PCab met on February 7, 2023.
  - 1. Our Students are being assigned SDCCD email accounts.
  - 2. There are proposed baccalaureate degree programs for Mesa, City and Miramar Colleges up for approval by the state.
  - 3. The college is working to find additional funding sources for paid internships for interns to work in our offices.

#### K. Program Review Committee (PRC): Miyoshi

As reported by Dina Miyoshi:

"Program Review will proceed this semester in the template. Nuventive will not be used for Program Review at this time and is scheduled to be rolled out in Fall 2023. Completed program reviews (using the template) will be due by May 31<sup>st</sup> to the Office of Institutional Effectiveness. Manager feedback of Program Review drafts is scheduled to take place between April 17<sup>th</sup> and May 8th. Resource requests will be completed using a link to a form where the lead writers can cut/paste what they have written in the template. These requests are due by April 5th. There are also training sessions planned for the different parts of program review and different types of resource requests. An email from the Office of Institutional Effectiveness containing all of the above information will be sent out the week of February 13th."

**L. Mesa Pathways Committee**: Howard Eskew's report was forwarded to the Department Chairs on February 8, 2023. As submitted by Howard Eskew via email:

## "Technology Workgroup:

The San Diego Mesa College (*student-facing*) <u>Academic and Career Pathways (ACP) webpages</u> are now live, and photos are continuing to be added to the ACP pages that correlate to the programs, with additional marketing in the works. This workgroup continues to work with the Mesa Pathways Leadership Team to identify a technology solution to consistently display, format and update program maps on our website.

### Onboarding and Career Exploration:

OCE's focus for spring semester will be on the creation and release of a digital Viewbook, as well as <u>Mesa Journeys</u> 3000, an updated version of Mesa Journeys tool.

#### **College of Continuing Education:**

CCE at Mesa Day will take place on Wednesday, March 15th from 8:30am-12:30pm. Students from CCE will be invited for presentations, classroom demonstrations and a resource fair. #### Student Success Teams (SST):

The Student Success Team will continue their pilot into spring, with monthly communication with students in the pilot cohort through the semester with additional targeted check-ins focused on summer/fall enrollment and submission of FAFSA. The bulk of meetings for the spring semester will focus on planning for the 2023-2024 academic year. A preliminary report on the SST pilot has been created and the outcomes will be shared in a future meeting.

#### Data Coaches:

The Fall 2022 Data Coaching pilot program successfully trained three data coaches over the course of the semester. A participant survey was conducted to collect feedback and improve the program in the future. A report recapping the Fall 2022 pilot program is available here: <u>Link to DC Debrief Document</u> and planning for the spring semester is in the works.

#### ACP Workgroup:

The ACP Workgroup reconvened at the Mesa Pathways working meeting on Wednesday, February 8th and will continue to meet monthly. The group determined that its work will be centered around two ACPs: Education & Guidance and Engineering, Math & Sciences.

#### Pathways Fellows:

On January 17th, the Mesa Online Success Team subgroup, OnRamp to Online, launched its four-week non-credit pilot course to a cohort of Promise Students who are new or fairly new to online learning. We are grateful to the Pathways Fellows, who collaborated to provide helpful contributions to this project. The Fellows also participated during Welcome Week and tabled alongside various campus resources. They were able to connect with new and continuing students, share resources and opportunities and continue to build their student contacts for their <u>Student Stories</u> project this semester.
