


Proposed Change to the AS Constitution regarding eligibility of faculty to serve in the positions of Secretary, Treasurer and Senator-at-Large

Current Constitutional Language of Article IV.3.F.3.a

Any active tenured member of the Faculty eligible for election to the Senate shall be eligible for nomination to the office of Secretary/Treasurer and Senator at Large.

Proposed Change: Any active tenured/tenure-track member of the Faculty eligible for election to the Senate shall be eligible for nomination to the offices of Secretary, Treasurer and Senator at Large.
