As reported by Leland Simpliciano:

"In October 2021, Mesa College was awarded the Minority Serving Institution (MSI) - Asian American Native American Pacific Islander Serving Institution (AANAPISI) Grant. Nearly 16% of the student population identifies as Asian American or Pacific Islander (AAPI). The presentation briefly covers what is AANAPISI, the importance of disaggregated data for the AAPI community, the current work being done at SD Mesa College along with goals and activities moving forward."

"The final salary advancement deadline for the Spring 2023 semester is February 27.

The deadline to submit sabbatical leave applications is March 1."

 - The Department Chairs met on February 8th. (We discussed the Spring 2023 Enrollment as New Business.)
 - Leland Simpliciano (Asian American/Native American/Pacific Islander Serving Institution (AANAPISI) Program Activity Director) will be our quest on February 22nd.
 - Vice President of Instruction (VPI) Isabel O'Connor and District Dean of Student Services Victor Devore will be our guests on March 8th.
- d. Curriculum Review Committee (CRC): Faculty Co-Chair Justin Estep As reported by Justin Estep: "CRC met on February 2. CIC met on February 9. The next CRC is on February 16.

City's Bachelor's degree (Cyberdefense) had some duplication challenges but has been approved and the curriculum has all been approved at CIC.

Miramar has received approval for their new Bachelor's degree (Public Safety Management). The curriculum has been created but has not been reviewed by CIC or me yet.

Mesa will be applying next. There are some questions about how many Bachelor's degrees the district can support.

Please continue to work on 2- and 6-year reviews. Please work with your colleagues at City and Miramar to make sure these reviews are completed.

e. *Program Review Committee (PRC)*: Acting Faculty Co-Chair Dina Miyoshi As reported by Dina Miyoshi:

"Program Review will proceed this semester in the template. Nuventive will not be used for Program Review at this time and is scheduled to be rolled out in Fall 2023. Completed program reviews (using the template) will be due by May 31st to the Office of Institutional Effectiveness. Manager feedback of Program Review drafts is scheduled to take place between April 17th and May 8th. Resource requests will be completed using a link to a form where the lead writers can cut/paste what they have written in the template. These requests are due by April 5th. There are also training sessions planned for the different parts of program review and different types of resource requests. An email from the Office of Institutional Effectiveness containing all of the above information will be sent out the week of February 13th."

2. Other Committees:

- a. *The Committee for Diversity Action, Inclusion & Equity (CDAIE)*: Chair Judy Sundayo As reported by Judy Sundayo:
 - "CDAIE last met on 2-3-23, with 23 persons attending.
 - The committee continues to support the celebration of Black History Month through a series of events on campus. We started with a great celebration of Rosa Parks, which was held on Feb 2nd and started with students, faculty and professional staff walking with social justice signs from the Black Studies Dept. through campus to the Rosa Parks Transit Stop, where there was a ritual libation, speeches and spoken word. Please invite your students and colleagues to attend the additional Black History Month events.
 - Dean Ailene Crakes made an informative presentation on Student Success & Equity at the meeting, which
 was well received.
 - CDAIE'S subcommittee on Employee Personal and Professional Development has completed the Land
 Acknowledgement draft. Presentations will be made to the Academic Senate, the Classified Senate and the
 Associated Students for feedback from those constituents before a presentation is made to PCAB.
 - The Mesa College Pride Center is scheduled to have their Grand Opening on Wednesday, Feb. 22nd at 11 am, in D-102
 - Lucio Lira, our LGBTQIIA Pride Center Director will be presenting at the 5th Annual CCC LGBTQ+ Summit, which will be held virtually April 19-20th 2023.
 - Women's History Month (March 2023) is in the planning stages, and it is hoped information will be disseminated soon.
 - Mesa College has approved the installation of two large lactation pods on campus, locations TBA, to support the needs of lactating students, faculty and professional staff.
 - The committee sponsored a Training on Civil Dialogue, which took place on Jan 6^{th.} Trainers were from the Institute for Civil Dialogue in Arizona. A diverse group of 20 Mesa students, faculty, professional staff and administrators attended the training. Since this initial training, the committee sponsored two additional practice sessions for those trainees who wanted to practice the civil dialogue facilitation techniques. Then, during convocation, the CDAIE chair facilitated two workshops introducing and demonstrating the civil dialogue process to a larger campus audience of approximately 100 persons. Additional civil dialogue opportunities are being planned for the spring on a variety of controversial topics, including Antisemitism. Everyone on campus will be invited to participate.
 - CDAIE will meet next on Friday, March 3, 2023, from 9 am 11 am."

b. Mesa Pathways Committee (MPC): Co-Coordinator Marisa Alioto

As reported by Marisa Alioto:

"Technology Workgroup:

The San Diego Mesa College (student-facing) Academic and Career Pathways (ACP) webpages are now live, and photos are continuing to be added to the ACP pages that correlate to the programs, with additional marketing in the works. This workgroup continues to work with the Mesa Pathways Leadership Team to identify a technology solution to consistently display, format and update program maps on our website.

Onboarding and Career Exploration:

OCE's focus for spring semester will be on the creation and release of a digital Viewbook, as well as Mesa Journeys 3000, an updated version of Mesa Journeys tool.

College of Continuing Education:

CCE at Mesa Day will take place on Wednesday, March 15th from 8:30am-12:30pm. Students from CCE will be invited for presentations, classroom demonstrations and a resource fair. Participants can register for free via Eventbrite: https://www.eventbrite.com/e/cce-mesa-day-tickets-460298785057

Student Success Teams (SST):

The Student Success Team will continue their pilot into spring, with monthly communication with students in the pilot cohort through the semester with additional targeted check-ins focused on summer/fall enrollment and submission of FAFSA. The bulk of meetings for the spring semester will focus on planning for the 2023-2024 academic year. A preliminary report on the SST pilot has been created and the outcomes will be shared in a future meeting.

Data Coaches:

The Fall 2022 Data Coaching pilot program successfully trained three data coaches over the course of the semester. A participant survey was conducted to collect feedback and improve the program in the future. A report recapping the Fall 2022 pilot program is available here: <u>Link to DC Debrief Document</u> and planning for the spring semester is in the works.

ACP Workgroup:

The ACP Workgroup reconvened at the Mesa Pathways working meeting on Wednesday, February 8th and will continue to meet monthly. The group determined that its work will be centered around two ACPs: Education & Guidance and Engineering, Math & Sciences.

Pathways Fellows:

On January 17th, the Mesa Online Success Team subgroup, OnRamp to Online, launched its four-week non-credit pilot course to a cohort of Promise Students who are new or fairly new to online learning. We are grateful to the Pathways Fellows, who collaborated to provide helpful contributions to this project. The Fellows also participated during Welcome Week and tabled alongside various campus resources. They were able to connect with new and continuing students, share resources and opportunities and continue to build their student contacts for their <u>Student Stories</u> project this semester.

As reported by John Crocitti:

"I met with Two (2) Nuventive representatives and Eliza Rabinovich.

I shared following concerns during our meeting:

- 1. Nuventive plans to extract outcomes and assessments from instructors' Canvas shells.
- 2. They promise anonymity, but I have doubts. I saw one feature where they had the ID numbers for all of the students.
- 3. They promise not to data mine. They will only scoop up data that "we" approve. But, I asked who is "we"? The Administration or the faculty?
- 4. In one of the screens displayed by Nuventive, they collected data on every exam, assignment, discussion board and extra credit that occured during the semester. This is well beyond collecting data on outcomes.
- 5. They promised not to sell advertising related to the data they collect. However, Nuventive is a small, family-owned company. What if a big company like Google or Microsoft purchases Nuventive next year. Will the promise still be honored?
- 6. I am concerned that Administration might try to use Nuventive to evaluate faculty in violation of the AFT contract."

 - 1. Rob Fremland said we need to nail down the process for developing the Faculty Hiring Prioritization (FHP) lists.
 - a. The process needs to be consistent every academic year.
 - b. The process is part of the list of 10+1 that are under Faculty purview.
 - c. The Classified Professionals should also develop a process for developing the Classified Hiring Prioritization (CHP).
 - 2. Ian Duckles asked how does the SDMC AS make this a part of the SDMC budgetary process?
 - 3. Can the resolution be approved by President's Cabinet as the SDMC AS Academic Affairs Committee's position papers were approved by President's Cabinet in the past?
 - 4. Senator at Large Veronica Gerace asked about the impact of the resolution on Accreditation.
 - 5. President Elect Andrew Hoffman submitted the following friendly amendment as the fourth item: "An approved rubric goes to the Planning and Institutional Effectiveness Committee (PIE), and then to the President's Cabinet for final approval; however, a rubric that is not approved is sent back to FHP for further discussion and revision."

Resolution 2023.3.1 – Nuventive Software (Replacement for "TaskStream") Canvas Shell Data Mining: Academic Senate President John Crocitti and Senator/Past President Rob Fremland

Move:

Second:

Whereas, an education software company such as Nuventive has the capability of mining personal data from Canvas shells such as, but not limited to individual student ID numbers and individual student scores on evaluation instruments;

Whereas, there is no there is no solid guarantee that such data will not be sold or used for advertising or that a small education software company such as Nuventive will not be purchased by a large company that intend to profit from student data mined from Canvas shells;

Whereas, there is no guarantee that an education software company such as Nuventive is capable of preventing criminal acquisition of data collected in Canvas shells by hackers and ransomware groups;

Whereas, misuse of data collected by commercial software enterprises and/or failure of such companies to prevent criminal access to such data has become a common occurrence on a global scale;

Whereas, course material created by instructors and placed in Canvas shells is also vulnerable data mining, sale, and theft through education software applications such as Nuventive;

Resolved, that education software companies such as Nuventive shall not access data directly from Canvas shells used by Mesa College faculty and classified staff;

Resolved, that data collection required for reasons such as, but not limited to accreditation, program review, and outcomes and assessments shall be submitted anonymously by faculty and classified staff to Mesa College employees who are responsible for entering such data into an education software application such Nuventive.
