

#### VI. GUESTS:

### A. Mesa College President Pam Luster:

- 1. The Academic Senate is doing a good job communicating with Faculty.
- 2. It feels like our semester is going well.
- 3. We are working to keep our budget challenges away from our Students and Faculty.
  - a. Bill Brothers said the news reports make it sound like the state of California is flushed with money.
    - President Luster reported the tax receipts will determine the May Budget Revision.
    - The system is receiving less funding and the funding is being divided differently.
    - We need to build a base for our needed expenses.
    - Community Colleges do not receive as much funding as the K-12 system.
    - We are visiting our local state representatives regularly.
    - The San Diego Community College District (SDCCD) is respected throughout California.
- . Student Centered Funding is in development.
- 5. The large jagged rocks by the Business/Technology Building and Mesa Commons will be broken down for the new quad infrastructure in about 18 months.
- 6. President Luster said she is hopeful that the voters will approve another bond that we can use to build additional English Classrooms.
- 7. Bruce Naschak asked about the promotional banners around campus.
  - a. President Luster reported we have banners for all Majors listed in our current College Catalogue, our Athletic Programs, HSI and Pride.
- 3. Carlynne Allbee asked if the Student Veterans have a new home.
  - a. President Luster reported their new office is bigger and better.

- 9. Students with Food and Housing Insecurities:
  - a. Rosiangela Escamilla said more of her students are reporting that they are facing Food and Housing Insecurities this semester.
  - b. President Luster reported Mesa College is currently working with Cal Fresh, CalWORKs, County Temporary Housing and other service agencies.
  - c. Approximately 30% of Mesa College Students report facing Food and Housing Insecurities during their time with us.
  - d. Our External Scan asks if housing is available close to Mesa College.
  - e. We are creating a central Mesa College location that will allow our students to connect with all available resources at the County of San Diego.

1. Associate Dean Bridget Herrin shared the alignment of Campus Goals with the State Chancellor's Vision for Success.

#### **Summary:**

Per the CCCCO Vision for Success goal alignment requirement, the campus has been working on setting goals that aligns with the Statewide Vision for Success as well as setting goals required by our Equity plan. The Vision for Success requirement includes Senate approval as well as Board approval by the May 31st deadline, Equity is due June 30. We have set goals in 5 areas for Vision for Success: Degree completion, Transfer, Unit Accumulation, Employment, and Equity. We have set goals in 4 areas for Equity: Completion, Transfer, Math and English Completion, and Fall-Spring Retention. Below you will find a brief timeline of the process so far.

  - 1. Please review the draft documents for the May 6, 2019 meeting.
- VII. ROUND TABLE TOPIC: Guided Pathways Self-Assessment Document (Guided Pathways Faculty Co-Coordinator Howard Eskew)
  - **A.** Howard Eskew reported we must submit the Self-Assessment Document to the state by April 30<sup>th</sup>.
    - 1. The draft document was sent to the Mesa College Academic Senate and Guided Pathways Inquiry Groups.
      - a. We received feedback.
    - 2. The document that is due on April 30<sup>th</sup> does not require the Academic Senate's signature.
    - 3. We will start work on Mapping on May 9<sup>th</sup>.
    - 4. The Summer Institute is June 3<sup>rd</sup>, 4<sup>th</sup> and 5<sup>th</sup>.
    - 5. There will be a fall 2019 session.
    - 6. There will be presentations for September 30<sup>th</sup> document and the document will need the Academic Senate's approval.
    - 7. It will be important to have discussions regarding the template.
      - a. We want to incorporate more inclusive statements.
  - **B.** Dina Miyoshi said we need to look at our End Goals.
    - 1. Dina Miyoshi said she is concerned that the focus on Mapping and Meta Majors is shutting out some of our students.
    - 2. Dina Miyoshi also said the San Diego Mesa College Mission Statement is relevant when we consider our students' End Goals.
    - 3. Dina Miyoshi reported she created a Guided Pathways PowerPoint presentation illustrating an idea about an alternate proposal for Mesa Pathways.
      - a. Howard Eskew asked Dina Miyoshi to send him a copy of her presentation by this Wednesday.
        - Howard Eskew said he wants the April 30<sup>th</sup> document to be representative of the entire campus.
    - 4. Guided Pathways Faculty Co-Coordinator Toni Parsons said we should not be fearful of the unknown.
      - a. Meta Majors is currently not defined.
    - 5. Inna Kanevsky said were told Meta Majors are not needed.
      - a. Then we were told that we do not have to call them Meta Majors.
  - **C**. Toni Parsons said the April 30<sup>th</sup> document gives us an idea of the activities we can have going forward.
    - 1. We can attach an addendum/statement from Faculty.
      - a. Judy Sundayo said she likes Toni's idea.
        - We can still ask how each item may be addressed differently since the April 30<sup>th</sup> document does not seem to be the final document.
  - **D.** Alison Gurganus asked if we can say we have not made progress regarding Essential Practices.
    - 1. Toni Parsons said we can say this is how we understand the process to be.
  - E. Inna Kanevsky asked why we can't say that we do not agree and this will not help our students.
  - F. Inna Kanevsky also said we need to note the important role Faculty plays as Advisors and Mentors.
    - 1. Faculty also works with the Counselors.

Student evaluations indicated overwhelmingly that the events which took place that week positively impacted their comfort level on campus, which as we know, improves student success.

The last workshop will focus on **Information Literacy**. specifically, practical steps on using and evaluating library resources, especially using an equity lens.
      - CDAIE will be co-sponsoring with the English Department, the film "The Ito Sisters: An American Story" on Tuesday, May 7<sup>th</sup> for Asian Pacific American Heritage Month. The film is an 80 minute documentary about 3
