- A. "Nuventive" Updates Acting Chancellor Greg Smith & Vice Chancellor Susan Topham/
 Director Peter Maharaj/Acting Dean Hai Hoang SDMC Office of Institutional Effectiveness:
 - Members of the SDMC AS posed questions about the possible security risks posed by data collection by the "Nuventive" software program from our Course Canvas Shells, Department Outcomes and Assessment Data and Department Program Review Data including the sales of our district's data to third party entities.
 - 2. There was also a question posed about whether the college and district has been able to benefit from Outcomes and Assessment Data we have gathered over the past several years.
 - 3. Summary from Hai Hoang Acting Dean of Institutional Effectiveness (I/E) for SDMC:

As reported by Hai Hoang:

"Acting Chancellor Greg Smith and Associate Vice Chancellor Peter Maharaj together answered some questions about Nuventive's data privacy and the district process of reviewing and approving a vendor. Vice Chancellor Susan Topham and Acting Dean Hai Hoang answered questions about program review, outcome assessment, and the purpose of Nuventive.

Nuventive was the result of the work by the districtwide workgroup which met throughout the year in 2022. The workgroup included various constituent groups at Mesa, at other colleges, and at the district. There were over 20 faculty who participated in the design and testing process throughout 2022. The list is available upon request -please contact Hai Hoang and Eliza Rabinovich.

Some reasons for switching to Nuventive:

- Taskstream contract expired
- Taskstream was not user friendly and had no reporting feature, which means it was challenging to review and discuss the information there
- Taskstream only allowed one person from the department to log in at a time
- Nuventive has a user-friendly interface, works for all programs, and has data report features that allow us to discuss and reflect
- It allows existing CLO to be imported into the platform
- Course assessments and benchmarks for student success can be detailed by CLO
- The Depart Outcomes Coordinator (DOC)/Chair can determine and schedule an assessment schedule by course
- The DOC/Chair can filter based on courses that are due for assessment and assign them from the platform
- Nuventive is currently being used by Grossmont College, Riverside City College, El Camino College, Santa Ana College, Imperial Valley College, Moreno Valley College, Oklahoma State, San Diego State, San Jose State, University of Mississippi, and University of Texas - Tyler, West Chester University, and many other education institutions.

Ultimately the idea is to design an easy workflow and decrease the workload for faculty.

For example, a faculty member shared that his area has 191 discrete courses and the DOC coordinates with around 65 contract, adjunct, and pro-rata. There are various challenges with the number of courses, the CLOs, the schedule changes, the coordination, open office hours to support other faculty, etc. There was no release time so faculty typically do not step forward to serve as a DOC for the school, which means the DOC role typically falls on the chair. Nuventive appears promising in fixing those problems.

 - "CDAIE last met on 4-7-23.
 - Cultural Unity Week successfully unfolded last week with 16 different events or activities exploring race, culture, gender and their importance to student success.
 - Festival of Colors, the annual celebration of diverse cultures through music, art, dance, drama, poetry and storytelling, was held last Thursday April 20th in the Quad. Performances from Mesa's Dance, Drama, English, and Music Departments were phenomenal, as were community performances from Danza Azteca, Ballet Folklorico, Belly Dancers, and Lion Dancers. This was our first on-campus celebration of Festival of Colors since the pandemic. It was well attended and lots of fun. The appetizers from around the world, provided by our cafeteria, were particularly scrumptious and went quickly. And remarkably there were no complaints about drumming.
 - The Statewide Black Student Success Week takes place this week. The kickoff was the Black Student Success Summit, last Friday, April 21st. It was extremely well attended and was facilitated in large part by students from throughout the District. Breakout sessions allowed for practical suggestions to help improve success rates. The faculty breakout session resulted in 5 Commitments to improve the success rates of Black students. Information from summit will be remanded to the Black Student Success Workgroup for follow-up and dissemination. For the remainder of this week, there will be a number of events taking place throughout the District to support the Black Student Success Initiative.

Resolution 2022.4.1 - Constitutional Changes (SDMC AS Committee on Elections): Dr. Veronica Gerace and the SDMC AS Academic Affairs Committee (Updated May 4, 2023)

Move: Mayasa

Second: Hoffman

Whereas, Duties of the Academic Senate Executive Committee include proposing amendments to the Senate Constitution, Bylaws or the Senate Rules in accordance with State and local governance as appropriate; and

Whereas, the Academic Affairs Committee reviews, considers and comments on standards established by State and local governance policies under the purview of the Senate; and

Whereas, Amendments to Senate Constitution may be adopted during regular Senate meetings, by a two-thirds (2/3) vote of Senators present at the regular meeting, given that the proposed amendments have been previously presented; and

Whereas, it is the duty of the Committee on Elections to ensure campus-wide communication about Elections and election procedures, be it therefore

Resolved that the following Senate Constitution amendments be ratified:

SECTION 7 - COMMITTEE ON ELECTIONS:

A. Composition:

The Committee shall consist of:

- A Chair who is not part of the Senate Executive Committee and at least two (2) Faculty members. Selection of the Chair shall be voted on by standing members of the committee and ratified by the Senate Executive Committee, as outlined by Article I, Section 5, Subsection D. Standing members shall be appointed by the
 - Committee on Committees. The total number of committee members, including the Chair, shall be an odd number representing a variety of departments.
- 2. If any member of the Committee on Elections wishes to be a candidate for a Senate Executive position, then that member must vacate their seat on the Committee on Elections prior to announcing their candidacy.

B. <u>Duties:</u>

The Committee on Elections shall be responsible for:

- 1. Supervising and administering elections for all Senate offices.
- Holding regular meetings with dates and times published/shared.
 Communicating the names/composition of The Committee on Elections with faculty as part of their regular communications with faculty.
- 3. Establishing election procedures.
- 4. Identifying vacancies, election procedures and recruitment strategies for filling Senate vacancies.
- 5. Developing a recruitment and election plan by January of each year to be shared with the Senate Executive Committee.
- 6. Maintain communication, membership, and election dates and policies during periods of elections.

 Sharing election procedures with all faculty at least one month prior to the election open period, as well as during the nomination period and through the conclusion of each election.
- 7. Resolving cases when there is doubt regarding election results, the eligibility of a candidate to run for office, membership in the Senate or membership status of the electorate.
- 8. Conducting all opinion polls that are initiated by the Senate.

This flex activity is inspired by my own experience with Mindful Leadership training with Dr. Tanis King Starck.
