A. Rob Fremland -Textbook Affordability Presentation: (LINK)

- 1. Rob Fremland reported he is the Mesa College Academic Senate's representative on the District Textbook Affordability Committee.
- 2. The district also has an Open Educational Resources (OER) Task Force.
- 3. The San Diego Community College District (SDCCD) Board of Trustees (BOT) has a goal that 15% of SDCCD courses use OER material.
 - a. We were able to get the BOT to expand the definition of OER material.
 - b. Rob reported that he hosted a FLEX workshop on OER materials in the past.
 - c. OER Librarian Lisa Burgert routinely sends out OER information.
 - d. There are some good discipline specific OER course materials available.
 - e. Andrew Hoffman said he would like to check with Articulation Officer Juliette Parker regarding OER Course Materials.
 - f. We will let the BOT know what Faculty needs in order to adopt OER course materials during a BOT presentation.
- 4. Faculty can allow their students to use earlier editions of a textbook to reduce costs for our students.
- 5. The SDCCD has an icon to denote that a class has "Zero Textbook Costs".
- 6. Low Cost Course Materials are helpful for our students.
- 7. The position of the Mesa College Academic Senate is Faculty determines what are the best materials for their courses and they can consider cost in the selection of their course material.

(Deans have 20 working days to review a course in their queue) The process can be held up for 30 working days when Departments Chairs and Deans do not review the courses in their CurricUNET queue right away.
