1. We are looking at the at the Legislative Analysis on the impact of AB 1705.

D. Curriculum Review Committee: Resch

As reported by Nathan Resch:

- "Guidance on AB 1705 implementation will be coming soon per VPI O'Connor.
- Jill had previously forwarded an email regarding district academic renewal policy updates. Students may now petition to have up to 30 units disregarded where it was previously limited to 12. Though this is a major shift, the qualifications for academic renewal remain in place:
 - o Students must have transcripts from all institutions they attended officially on file;
 - o They must successfully complete 15 units in an accredited college or university, with a grade point average of at least 2.0, subsequent to the work to be disregarded;
 - o A minimum of one year must have elapsed since the coursework to be disregarded was completed.
- Private institutions will be added to Assist.org though it was noted that updates from the CSUs and UCs have been slow.
- AB 1111 Taskforce has produced some ideas on how to create common course numbers and possible shared curriculum related items such as course descriptions, student learning objectives and course outlines. For example, course outlines may have a common shared outline section that also includes a local section for topics taught at a specific college/district. VPI O'Connor welcomes discipline specific feedback and ideas.
- The newly proposed district GE pattern which aligns with Title 5 Revisions and Cal GETC was voted on to support by CRC and will be voted on at the next Mesa academic senate meeting. The documents can be found on the [CIC board docs page here](#).
- There was early discussion about how GPA calculations would appear on student transcripts as there is now an option to list GPA by major or cumulative. It was unclear whether both could be listed, or if it was a decision of one or the other. It was noted that cumulative GPA is used by students in several ways, including student driving insurance discounts, scholarship opportunities, and athletic eligibility. The transfer center also has tools that can help determine specific GPA calculations such as major GPA for the purposes of submitting applications based on college requirements."

"A reminder that this is an update year. There have been questions about what is required in this year 2 of the 4-year cycle. Since the comprehensive program review document for year 1 was submitted at the very end of spring semester, it is possible that programs may not have many (or any) updates/changes to what they had already submitted (especially if they are not planning to submit any resource requests this year). December 4th is the first draft deadline to provide deans/managers a dedicated window to look at the program review drafts and provide feedback (though Nuventive does not actually lock during this time). The final deadline for program review and resource request submission is February 5th. If you have any questions, let me know."

"Academic and Career Pathways (ACPs):

The deadline for academic programs to make adjustments to their ACP placement was Monday, October 16th. Many thanks to the departments who submitted updates to their placement, as academic programs may now be placed in up to three Academic and Career Pathways. Mesa Pathways Leadership Team is now in the process of updating these programs listings, which will be reflected on the Academic and Career Pathways website by late-November: <https://www.sdmesa.edu/academics/v2/academic-career-pathways/index.shtml> .

These ACP updates will also be submitted to the district so that these changes can be reflected in the updates to CCCApply. In future terms, incoming students will be able to select their major via ACP in CCCApply.

This event provided an opportunity for Mesa Success Coaches and their students to get to know one another in person.
