She will share the list of committees periodically and in an easier to read format once committee chairs make updates.

Veronica also shared that she inquired as to whether the Canvas login could be changed so faculty do not have to input their SDCCD ID number. She shared that Brian Weston informed her that the login would be changing overall in January to be similar to the Outlook email login where we input our email address and a password. Senators asked if it would require an authentication. Veronica said she would investigate further and get back to everyone."

"Refreshments (drinks and cake) were provided for today's meeting as you can see. Tonya Whitfield stated that students make our refreshments generally from Leftovers (of various kinds) from other events they may have. Thus, there is no guarantee that anything more than drinks will be available to offer for any given meeting which is why we only are charged half price. Another option would be to ask the 7250 Cafeteria to provide snacks which would be more expensive. Trays are another option, that would also likely be more expensive. X. ROUND TABLE TOPIC: New District Parking Enforcement System (Hoffman)

As reported by Andrew Hoffman:

"The Round Table discussion focused on the district's plan for automated (or paperless) parking. This means that in the future, physical permits, such as the hanging permits, will no longer required. Instead, electronic readers will be attaching to Parking Services vehicles, and they will read the license plate numbers on cars in our parking lots. These numbers will be crossed checked with a database to ensure that the vehicle does indeed have a registered 'virtual' permit.

The intention is to greatly speed up the time it takes Parking Services to go through parking lots checking cars.

Several issues came up. The system will cost \$240,000, paid for by Prop S and N funds. It is expected to be self-sustaining.

Parking Services is separate from Police, and they will not share data with the police.

Senators Jesse Keller and Sam Lee brought up reservations about the promise not to share data, citing examples from other regions in the area where such data was shared with law enforcement and ICE (Immigration and Customs Enforcement).

President Hoffman offered to invite Vice Chancellor Joel Peterson to speak to the Academic Senate at our next meeting."
