• "District still pushing for Nuventive to extract data from Canvas shells. If faculty is committed to keeping Nuventive out of Canvas, then people must remain vigilant and enforce the Senate

resolution that prohibits data extraction from Canvas.

• I brought up issue of security, specifically ability to lock classroom doors from inside. District still cites the cost. Two administrators approached me after DGC to lend support.

I attended an event at Miramar intended to promote an easy pathway from the College of Continuing Education to the credit colleges. There were discussions about Competency Based Learning, Credit for Prior Learning, and Credit by Exam. Among proposals, one was for credit-college faculty to devise exit exams for CE courses. Passing the exam would confer college credit in the appropriate course. Another proposal was for credit-college faculty to teach courses on CE campuses."

The mission of San Diego Mesa College Disability Support Programs and Services, in partnership with students with disabilities, is to facilitate student success in education by providing specialized services and advocacy necessary for equal access to higher education.



Purpose The DSPS

Department was established to more fully accommodate the academic and service needs of students with

disabilities.



Student participation in the program is voluntary and all information is kept confidential.

Disability Related Laws



DSPS provides programs and services for students with disabilities in compliance with both Section 504 of the Rehabilitation Act of 1973 and the Americans with Disabilities Act (ADA).

Services and Accommodations


The DSPS program offers many services for students with disabilities. A list of most common services, accommodations, and special equipment is available on the <u>DSPS</u> website.



DSPS Counseling

- Eligible students are assigned a DSPS Counselor.
- DSPS Counselor evaluates the disability verification and the student's educational limitation(s).
- The DSPS Counselor authorizes accommodations and services.
- Students must meet with their DSPS Counselor at least once a semester to review progress toward the student goal and effectiveness of the authorized accommodations.

Reasonable Accommodations



Reasonable accommodations provide access to education in a timely manner without changing the fundamental elements of the course.

DSPS Strives to support Mesa College in the inclusion of our students as independent, responsible, and productive members of the community.



Specialized Classes and Programs



Specialized instruction for students with disabilities is available. Please review the Class Schedule and Mesa College Catalog to assist you in determining which DSPS courses might best support your academic needs.

To enroll in classes and DSPS courses use <u>Reg-e</u>, the district's online registration tool.

If a specialized DSPS course requires an "Add Code" (See Class Schedule) see your DSPS Counselor or the class Instructor.

Applying for Services

In order to be assigned a counselor and receive services, the following steps must be completed:

- ❖ Be an active SDCCD student and registered in classes
- Submit a <u>DSPS Application</u>
- Submit the Certificate of Completion received at the end of this presentation
- Submit a <u>Verification of Disability</u> form or other acceptable verifications
- Complete college placement tests, if this has not been completed, please call and schedule with the Assessment Center 619-388-2178

Responsibilities

- All students are responsible to comply with the SDCCD Student Code of Conduct as listed in the Mesa College Catalog.
- Once you are assigned a counselor, you are required to meet with them once a semester.

Disability Groups

There are eleven disability groups that are eligible for DSPS services in the California Community College System:

- ❖Acquired Brain Impairment (ABI)
- ❖ Deaf and Hard of Hearing
- Psychological Disability
- ❖ Mobile Disability
- ❖Speech/Language Disability

- ❖ Visual Disability
- ❖ Developmentally Delayed Learner
- Learning Disability (LD)
- ❖ "Other" Disabilities

It is important that you identify which category best describes your disability and determine the appropriate professional who can provide you with that required verification.

Acquired Brain Impairment (ABI)

ABI is defined as a brain impairment caused by external or internal trauma, resulting in total or partial functional limitations that adversely affects or limits a students educational performance by impairing:

- Language and/or speech
- · Cognition, information processing
- Memory and attention
- · Psychosocial behavior, or
- Physical functions

ABI can be verified by a psychologist, neuropsychologist, or physician.

Deaf/Hard of Hearing (HOH)

- ng (HOH)
- An individual is considered deaf when she/he cannot understand spoken language with the use of a hearing aid. A person who is deaf may or may not use sign language, or read lips.
- An individual who is hard of hearing can usually benefit from spoken language when using amplification or other adaptations.
- The major challenge in a hearing environment is oral communication.

- Many Deaf people (and some hard of hearing people) use sign language when communicating with others.
- The choice to use or not use speech is a matter of personal preference.
- HOH students may use an FM listening system and/or notetaker.

Psychological Disability

Psychological disability is defined as a persistent psychological or psychiatric disorder, emotional or mental illness that adversely affects educational performance.

A psychological disability can be verified by a psychologist or psychiatrist, physician, Marriage Family and Child Therapist, or a licensed clinical social worker.

Mobility Disability

Mobility limitation is defined as any orthopedic or physical impairment that causes a serious limitation in locomotion or motor functions in the educational environment.





Mobility limitation may include impairments caused by: congenital anomaly; disease; amputation; fractures and burns. Other conditions in this category include arthritis, spinal cord injury, polio, M.S., muscular

Speech/Language Disability

Speech disability is defined as a disorder of expressive or receptive language, articulation, voice, or fluency of speech.

This disability can be verified by a licensed Speech and Language Pathologist.

Visual Disability

Visual limitation is defined as a total or partial loss of sight that adversely affects a student's education performance.



This disability can be verified by a physician, or a licensed vision professional



Visual limitation does not apply where the loss or impairment is the result of a psychological condition or an Acquired Brain Impairment (ABI)

Developmentally Delayed Learner (DDL)

- The DDL is a student who exhibits the following characteristics:
 - Below average intellectual functioning
 - Potential for measurable achievement in instructional and employment settings
 - Difficulties may be in communication, learning, or self-direction, and/or social functioning

This disability can be verified by the DSPS Coordinator or DDL specialists using the documentation from referring agency.

"Other" Disability

This category includes all other verifiable disabilities and health related limitations that adversely affect education performance but do not fall into any of the other categories.

- "Other" disabilities include:
 - Conditions like having limited strength, vitality, or alertness due to chronic or acute health problems.
 - Examples: Attention Deficit, Epilepsy, Heart Conditions, HIV/AIDS, Cancer

This disability group can be verified by a licensed physician.

Learning Disability (LD)

A Learning Disability is defined as a persistent condition of a presumed neurological dysfunction. This dysfunction continues despite instruction in standard classroom situations.

LDs are exhibited by:

- Average to above-average intellectual ability
- Severe processing deficit(s)
- Measured achievement in an instructional or employment setting

This disability must be verified using the California Community College LD Eligibility Assessment model. Qualified DSPS staff members can both verify and assess eligibility for services related to a Learning Disability. Documentation of appropriate test results from a referring agency may also be used in the community college LD eligibility model assessment. Test scores must not be more than 3 years old.

Learning Disability (LD)

(Continued)

Even though a student has been diagnosed previously, the community colleges need to determine eligibility for their LD programs and services. The most recent psychoeducational assessment, even if more than three years old, would be helpful, for history of LD

You should request assessment:

- if this is your first LD referral
- if your previous LD testing was done prior to age eighteen; or
- if you were tested more than three years ago.
- Please view the DSPS LD Assessment Web page for more detailed information regarding the LD eligibility assessment procedure and related downloadable forms.

Submitting Required Documents

- Students may be requested to submit additional documentation that will assist in clarifying the services that are most appropriate to their specific disabilities.

Remember, you will be assigned a counselor after you have completed the Five Steps to Mesa and DSPS Services:

- Be an active student and enrolled in classes
- Schedule and take necessary Placement Tests prior to meeting with your counselor.
- Submit Mesa College DSPS application
- After viewing this slide show, print and submit a signed <u>Certificate</u> of <u>Completion</u>.
- Provide DSPS with verification of your disability.
