A. Fraudulent Student Enrollments - BOTs: Resch

- "Problem across the state; Batch drops/sweeps happening before first day of courses
- may include tag on rosters in the future that indicate potential fraud student
- Have been requiring students flagged as potential fraud to show up on campus to validate information
- Getting around ID Me; Chancellor's office investing \$20M into fraud prevention; Lexis Nexis fraud prevention pilot being used with Mesa to mitigate fraud; prevent issues before they happen; Targets GE fully online
- sweep each week for students to certify; list to deans who send to faculty to determine drops;"
- B. Campus Safety & Emergency Response: Resch
  - 1. Jacqueline Collins has been attending school meetings to provide information.

- "Single Sign on MFA issues: 7000 open tickets initially; opened support on Mesa campus through Mesa technology center/Printing which is the only place to handle resetting passwords/ providing tokens for students without 2<sup>nd</sup> authentication method such as phone. Admissions can only handle resetting myportal/peoplesoft not MFA.
- Issue with evening students not able to get live support. LRC can provide some basic login help but only technology services can help with password reset."

D. Curriculum Review Committee (CRC): Resch

As submitted by Nathan Resch:

- "CurriQunet META continues to hold training meetings on Fridays; there was a brief discussion related to how outcomes are displayed in the all fields report as well as confusion over the display of some values (for example: "Yes" is displayed, but it does not indicate "Yes" unless there is a checkmark next to it).
- Discussions have begun related to Corse Learning Outcomes and how they show in META and whether they should show as part of
  the Course Outline of Record (since we are aligned curriculum, there are complications as each campus has different Outcomes and
  each campus calls them different things CSLOs, CLOs, SLOs etc.).
- There is an official catalog sub-committee of CRC which is outlined in the AS constitution. Seeking members.
- Justin Estep is forming a District GE taskforce, email him if interested.
- The 2025-2026 catalog is slated to be our first "Electronic" catalog.
- Be aware the curriculum deadlines for the 2026-2027 catalog will move to the May CRC meetings in time to reach CIC before Summer (no longer first September meetings).
- AB 1111 Common Course Numbering: 6 templates have been released (ENGL C1000, POLS C1000, ENGL C1001, PSYC C1000, COMM C1000, STAT C1000) and are posted publicly on the State Chancellor's website. There are 14 templates for those that also include honors and support courses. At SDCCD we are using the core 6 as our support courses are separate courses."

- "GOV 101 orientation and governance survey update. Very few responses on the governance survey; related discussion on how to improve number of responses.
- Partially updated list of committees that are shared governance and operational as well as chairs; updates to continue.
- Update on Mesa2030 roadmap and related discussion on whether COVID changed anything related to Mesa2030 as it was
  developed prior to that time. Suggestion was to start with the Mesa 2030 goals (Completion, Scholarship, Community, Pathways &
  Partnerships, Stewardship) to evaluate and provide feedback.
- Began reviewing the Integrated planning calendar and deliverables for PIE 2024-2025."

- · Students receive email announcement through canvas about election related stress services through student health
- \$384K students did not pay fees related to certification/testing many in Allied Health fields
- Bill going through State which will allow Baccalaureate degree students access to promise program
- Efficiency of college currently 15.61 (BOTS did a number on this); headcount at Mesa 20,400 students first time since COIVD;
- Strong work force Faculty Institute 25 faculty to evaluate data equity gaps and setup action plans for courses up to \$2k contact Alex Berry (Recent email from Rachel Russel)
- 200 students get \$500 grants for transportation and housing.
- IE had the program review and outcomes kickoff last Friday.
- Safety update RAD Training 10/13 includes students; 10/17 Earthquake preparedness shakeout safety fair in quad
- CCERT 60 trained Johana Aleman to lead CCERT Incident command team for major event response; 10/31 training; 90% of building evacuation plans done and there will be a teams channel to share with campus.
- 9/25 pep rally; 10/23 career fair at Gym
- Bond Measure HH 55% of SD approve to pass, 3.5 Billion, We can tell people to vote not how to vote (using district equipment/time).
