III. GUEST(s):

A. Mesa College Bookstore Supervisor Rob Meyers – Equitable Book Access:

- 1. Students can purchase access to digital course materials.
- 2. One option allows Students to purchase access to digital course materials that is available on the first day of class.
- 3. The second option allows Students to opt in within a certain number of days and agree to pay a fee for access.
- 4. The opt-out option is probably the most equitable option for Students.
 - a. However, there are examples of publishers making it very difficult for Students to opt-out with multiple steps required to opt-out.
- The district is in the process of providing our Students with district email accounts, which will assist with our Students' abilities to purchase digital course materials.
- 6. Institutions like SDSU can tie fees for digital course materials access to the same account as the Student Health Services fees.
 - a. Our district does not have the option to do.
- 7. We have printed out digital textbook access codes and placed them in envelopes to sell to our Students.
- 8. The Bookstore has worked with Languages Department Assistant Chair Michael Harrison and his Department Faculty to provide products that allow our Students to have instant access to digital course materials.
- 9. Students can use their financial aid funds to purchase codes to access digital course materials.
- 10. We are working to make more digital course materials available to our Students.

VIII. PLANNING/COMMITTEE REPORTS:

A. Academic Affairs: Gwin/Torres

As reported by Mary Gwin:

"The Academic Affairs committee met on 9/19/22. We discussion potential Senate Constitutional changes. No actions were taken."

B. Academic Senate: Crocitti

1. As reported by John Crocitti:

"I explained the mask mandate is supported by VC Greg Smith and AFT President Jim Mahler. I suggested writing to Mahler if people wanted the mandate lifted. I also advised people to make public comments at Thursday's Board meeting."

a. Statement from the Mesa College Chemistry Department as reported by Paula Gustin:

"The District Policy described by Greg Smith in his communication on Jun 14, 2022 stated, "Face coverings will continue to be required for all individuals onsite at District facilities during periods of high transmission of COVID-19 in San Diego County."

Currently San Diego County is under low COVID-19 transmission with wastewater and other data showing this decline.

Our department was expecting that District had ample time to develop a mechanism to alert the Colleges of low transmission and change the mask policy to "optional". This has not occurred, and it is not acceptable.

Many STEM students and faculty spend many hours in laboratory courses (6 hours of lab for just one class) in full Personal Protection gear (goggles, laboratory coats). The airflow in chemistry labs due to strong fume hoods makes it similar to outside ventilation.

Requiring STEM students and faculty to continuing wearing masks during low transmission is not sensible. An optional mask policy would allow students and staff that want to continue wearing masks to wear them without any issues.

In addition, continuing the required mask policy in the building does NOT reflect the greater San Diego community's masking policies. We are adhering to strict mask policies that only healthcare settings are currently requiring.

It will also allow a reprieve during low transmissions to avoid mask fatigue

The "Masks required" policy can be reinstated when and if the County reaches high transmission category. The District Policy was set and should be followed."

b. Statement from Connie Renda as reported by Connie Renda:

"The mask mandate should change to "mask recommended" for faculty and students. It poses a tremendous burden on student learning. The students cannot hear and understand faculty clearly and completely when they are speaking through a mask. Additionally, students for whom English is not their first language already have challenges with communication and adding a mask exacerbates this problem in the classroom, in office hours, and with their classmates. For students and faculty who want to wear masks, they are welcome to do so but it should not be mandatory for those of us who chose to be vaccinated and want to teach our students fully."

2. As reported by John Crocitti:

"I warned people to be careful when turning left into Mesa College Drive from the intersection between Allied Health and the Parking Garage. Drivers in the middle lane have been illegally making a left turn. A pedestrian was nearly hit by a driver making the illegal turn and other accidents have narrowly been avoided."

C. Curriculum Review Committee (CRC): Resch

As reported by Nathan Resch:

"As announced in President Hand's Weekly Update VPI Isabel O'Connor has been appointed as a Chief Instructional Officer representative on the The Common Course Numbering Task Force. VPI O'Connor mentioned at the last CRC meeting that the district also has begun formulating a plan and work group who look to implement the mandated common course numbering across California Community colleges specified in AB1111.

-A reminder that the Academic Senate for California Community Colleges has two surveys available for providing feedback to AB 928 and AB1111. The feedback for AB928 has a deadline of October 1st, so if you have been thinking of jumping on that one in particular now is the time. Although there is no posted timeline for AB1111 feedback October 1st is probably a good deadline to also look to meet. Thankfully I have some suggested comments from Juliette Parker that can be modified for AB 928 which I will pass along after the meeting to the Chairs DL along with the survey links.
